Subject: Beti Bachao Beti Padhao (BBBP) Scheme - release of funds to Govt. of Uttar Pradesh during 2015-16.

Madam/Sir,

I am directed to convey the sanction of the President to the payment of **Rs.137,04470/- (Rupees One Crore Thirty Seven lakh Four thousand Four hundred and Seventy only)** to the **Government of Uttar Pradesh** as grants-in-aid as 1st installment (six months) during the financial year **2015-16** for implementation of Beti Bachao Beti Padhao (BBBP) Scheme in 17 districts i.e. Baghpat , Gautam Buddha Nagar , Ghaziabad , Meerut , Bulandshahr , Agra , Muzaffarnagar , Mahamaya Nagar , Jhansi , Mathura, Lucknow, Bareilly, Kannauj, Allahabad, Gorakhpur, Varanasi and Kanpur Nagar. **An amount of Rs. 187.98 lakh was released in the F.Y. 2014-15.** However, due to un-utilization of the funds, the same is revalidated vide letter No. 4-16(8)/2014-WW dated- 15/06/2015 for carrying out the activities such as Inter-Sectoral Consultation/ meetings and meetings of State Task Force, Training & Capacity Building-Orientation and Sensitization programme, Innovation and Awareness generation Activities, Monitoring and Evaluation and Documentation at State/District level and Sectoral activities of M/o Human Resource Development & M/o Health and Family Welfare in selected district for the F.Y. 2015-16. The component wise maximum ceilings of expenditure are as under:-

The State Government will maintain separate records of expenditure incurred for implementation of **Beti Bachao Beti Padhao (BBBP) Scheme** and they are required to furnish separate Statement of Expenditure along with Physical Progress Report every quarter and Utilization Certificate is to be submitted half yearly.
4. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.
5. The expenditure is debitable to the 3601 (Major Head) ; 03-Grants for Central Plan Scheme (Sub Major Head), 358-Social Welfare Child Welfare (Minor Head), 02-Beti Bachao Beti Padhao (Sub-Head); 02.00.31- Grants-in-aid-General (Object Head) in Demand No. 108 Ministry of Women & Child Development 2015-16 (Plan).
6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D-Wing, Ground Floor, New Delhi.
7. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
8. This sanction issues with the concurrence of JS& FA vide their **Computer. No. 785** dated 05.11.2015.
