Subject: Beti Bachao Beti Padhao (BBBP) Scheme - release of funds to the Longleng of Nagaland during 2016-17.

Madam/Sir,

I am directed to convey the sanction of the President to the payment of **Rs. 24,04,750/- (Rupees Twenty Four Lakh Four Thousand Seven Hundred Fifty only)** to the Longleng of Nagaland as grants-in-aid as 1st installment (six months) during the financial year **2016-17** for implementation of Beti Bachao Beti Padhao (BBBP) Scheme in Longleng of Nagaland. An amount of Rs. 8,45,750/- (Rupees Eight Lakh Forty Five Thousand Seven Hundred Fifty only) was released in the F.Y. 2015-16 vide Letter No. 12029/1/2015-BBBP dated 30.09.2015.. However, due to un-utilisation of the funds, the same amount has been deducted from the 1st Instalment being released herewith for FY 2016-17. Government of Nagaland has also requested for its revalidation for use in 2016-17 vide letter No. SW/2/GEN-19/14(pt) dated 07.09.2016.

The District Administration will maintain separate records of expenditure incurred for implementation of **Beti Bachao Beti Padhao (BBBP) Scheme** and they are required to furnish separate Statement of Expenditure along with Physical Progress Report every quarter and Utilization Certificate is to be submitted half yearly, directly to the Ministry of WCD, GoI with a copy marked to the Principal Secretary, Department of WCD, Govt. of Nagaland.

4. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

5. The expenditure is debitable to the 2235 (Major Head); 02 – Grants for Central Plan Scheme (Sub Major Head); 102 – Social Welfare Child Welfare (Minor Head); 41.00.31 – Grant-in-aid-General (Object Head) in Demand No. 97 Ministry of Women and Child Development 2016-17 (Plan).

6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the Longleng of Nagaland may be made through ECS/NEFT. The State Accountant General/District Collector will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D-Wing, Ground Floor, New Delhi.
