**Subject: Release and revalidation of funds to the Jaipur District of Rajasthan during 2017-18 under Beti Bachao Beti Padhao (BBBP) Scheme – reg.**

Madam/Sir,

I am directed to convey the sanction of the President to the payment of **Rs. 26,51,001/- (Rupees Twenty Six Lakh Fifty One Thousand One only)** to the Jaipur District of Rajasthan as grants-in-aid as 1<sup>st</sup> instalment (of six months) during the financial year 2017-18 for implementation of Beti Bachao Beti Padhao (BBBP) Scheme.

2. An amount of Rs. 19.50329 lakh (Rupees Nineteen Lakh Fifty Thousand Three Hundred Twenty Nine only) was revalidated to the District in the F.Y. 2016-17. However, the District has submitted the Utilisation Certificate (UC) and Statement of Expenditure (SoE) of Rs.13,50,833/- only and an amount of Rs. 5,99,499/- is available with the district.

3. The UC and SoE furnished by the District have been accepted by the Ministry. **The approval of the competent authority is also granted for revalidation of the unspent balance amount of Rs. 5,99,499/-** (Rupees Five Lakh Ninety Nine Thousand Four Hundred Ninety Nine only) for its utilization during current FY 2017-18.

4. Thus, the total amount of Rs. 32.505 lakh (Rs. 26.51001 lakh released as 1<sup>st</sup> Instalment + Rs. 5.99499 lakh revalidated) is available with the Jaipur District of Rajasthan for carrying out the planned activities under Beti Bachao Beti Padhao (BBBP) Scheme during the financial year 2017-18. The District Administration will maintain separate records of expenditure incurred for implementation of Beti Bachao Beti Padhao (BBBP) Scheme and they are required to furnish separate Statement of Expenditure along with Physical Progress Report every quarter and Utilization Certificate is to be submitted half yearly, directly to the Ministry of WCD, Gol with a copy marked to the Principal Secretary, Department of WCD, Govt. of Rajasthan.

7. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

8. The expenditure is debitable to the 2235 – Social Security and Welfare (Major Head); 02 – Social Welfare (Sub Major Head); 02.103 – Women's Welfare (Minor Head); 70 – Mission for Empowerment and Protection for women; 09 – Beti Bachao Beti Padhao Campaign; 70.09.31 – Grants-in-aid General in Demand No. 99 Ministry of Women and Child Development 2017-18.

9. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the Jaipur District of Rajasthan would be arranged through NEFT/ECS. The State Accountant General/Deputy Commissioner will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.

10. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
