Subject:- Revalidation of budget amount of Rs. 20.8 Lakh (Rupees Twenty Lakh Eighty Thousand only) for utilization in financial year 2017-2018 for implementation of the scheme of Beti Bachao Beti Padhao (BBBP) - Regarding.

Madam/Sir

I am directed to refer to your letter No. ICDS/Training/BBBP/2016-17/530 dated 15.02.2017 on the above cited subject and to convey the approval of the competent authority for revalidation of Rs. 20.8 Lakh (Rupees Twenty Lakh Thirty Eighty Thousand only) remain available as unspent amount, with State Govt. / District Collector for implementation of BBBP Scheme during financial year 2017-2018.

2. The above fund remain unutilized out of allocated funds to the Ahmednagar District of Maharashtra for Rs. 32.45 Lakh in the consolidated sanctioned/released to the State Govt. for Rs. 319.5126 Lakh (Includes release amount of Rs. 160.78260 Lakh + revalidated amount of Rs.158.73) for implementation of the Scheme of Beti Bachao Beti Padhao (BBBP) scheme in the State of Maharashtra and 10 districts including Ahmednagar Districts of Maharashtra during the financial year 2015-2016 vide letter No. 12025/1/2015-BBBP dated 15.11.2015. It may be ensured that the expenditure is made as per the schematic norms.

3. It is also intimated that the Ministry has accepted the UC and SoE in respect of Ahmednagar District for Rs. 11.65 Lakh. The **expenditure**

under the following components of BBBP Scheme are beyond the prescribed norms of the BBBP and hence will be borne the Govt. of Maharashtra from its own resources.
