The maternity benefit to the beneficiaries' bank/post office account are to be transferred from the Escrow Bank Account of States/UTs using the Common Application Software of PMMVY through PFMS.

2. It may be stated that training of Nodal Officers/Master Trainers on PMMVY-CAS and PMMVY Guidelines is required to be conducted on urgent basis for seamless implementation of the scheme. This Ministry has formalized its plan to conduct Regional Workshops to train the officers on the aforesaid issues (**copy enclosed**).


3. The following arrangements need to be done for the workshop:
