The Voluntary Organization namely Morigaon Mahila Mehfil, P.O. Morigaon, Dist. Morigaon, Assam, Registered under SRA XXI of 1860, bearing No. 126 of 1980-81 was aided under Integrated Scheme for Women's Empowerment (ISWE) Programme. During the year 2009-10 an amount of ₹. 15.30 lakhs was released out of sanctioned grant of ₹. 16.60 lakhs under goatery project for 50 beneficiaries in 04 units. The loan amount under the said project for 50 beneficiaries is ₹. 14.00 lakhs.

The said Mother NGO had requested vide their letter dated 01.06.2012 to waive of the loan component of the goatery unit. However, the request of the Mother NGO was not accepted by the Competent Authority. On our request, State Board vide their letter dated 31.10.2012 directed the concerned organization to recover the loan amount from the beneficiaries in time bound manner and deposit the same to Central Social Welfare Board.

A Show Cause Notice dated 20.12.2012 was issued to the Mother NGO due to non-adherence of terms & conditions of ISWE project. In the reply dated 8.2.2013, Mother NGO has requested to allow them to return the amount of ₹. 9.00 lakhs on quarterly basis i.e. ₹. 25,000/- per quarter, which was not accepted by the competent authority. Out of loan amount the Mother NGO has recovered ₹.1,64,000/- from the beneficiaries till date and refunded to Central Social Welfare Board.


