Subject: Invitation to participate in “Women of India Organic Festival 2018” at Indira Gandhi National Centre for Arts (IGNCA), near India Gate Lawns, New Delhi on behalf of Ministry of Women and Child Development —reg.

Madam/Sir,

Women farmers and entrepreneurs in the field of organic products are invited to apply for allotment of stall to showcase and sell their products in Women of India Organic Festival, 2018 from 25th October to 4th November, 2018 at Indira Gandhi National Centre for Arts (IGNCA), near India Gate Lawns, New Delhi as per the following terms and conditions below:

1. The stalls are available from 25th October to 4th November, 2018.
2. All Participants/Organizations must reach Indira Gandhi National Centre for Arts (IGNCA), near India Gate Lawns, New Delhi by October 25th, 2018 to take possession of their stalls by October 25th, 2018.
3. Product should be sold on fixed price. There should not be any bargaining. The sales details are to be shared with MWCD.
4. Identity Card (PAN Card or Aadhar Card) along with a copy of the letter of Invite is to be brought.
5. Once your participation is confirmed by the Ministry, you cannot cancel the same.
6. If you sublet or give your stall to someone else your allotment will be cancelled immediately.
7. You have to abide by the instructions being issued by the Ministry during the period of Festival.
8. Please note, meat, non-organic products are strictly not permitted to be exhibited or sold during the Festival.
9. The participants who would be packaging their organic products without use of plastic will be given preference.
10. The Ministry will provide the following facilities to the selected participants from outside Delhi NCR.
 - a. Reimbursement of Travelling Allowance (to and fro Sleeper Class Fare/State Transport Bus Fare) to two participants from one organization/per stall on production of original tickets for onward journey and a copy of tickets for return journey.

- b. Reimbursement of Luggage Charges for one way to one participant on production of original tickets from railway/state transport bus for reasonable quantity of goods.
- c. For Reimbursement of TA/ luggage charges, the TA Mandate form (also attached herewith) should be duly filled in block letters by the participants along with relevant documents (Original Tickets of arrival+ Merchandise Receipts by Railways or State Transport + Copy of return Ticket), bank details and should be handed over to the concerned person at the venue. Do not book your merchandise by private transport to enable smooth reimbursement.
- d. Free accommodation to participants on twin sharing basis.
- e. Stall at Indira Gandhi National Centre for Arts, (free of cost) with one table and two chairs.
- f. Reasonable arrangements will be made to pick the participants from railway station/bus stand & drop them at place of stay/venue on arrival.

11. The Ministry will provide the selected participants belonging to New Delhi-NCR with Free Stall with one table and two chairs.
