

6.Terms & Conditions:

1. 1. Price quoted should be inclusive of all applicable taxes and levies.
2. 2. The office reserves the right to change the quantity or cancel the tender as per its requirement at any stage.
3. 3. Delivery should be within **1 weeks** from the date of receipt of order for supply.
4. 4. The supplier may be asked to submit the suitable test certificate to confirm the specifications mentioned above
5. 5. Sealed quotation should reach on or before date as mentioned above.
6. 6. The Office reserves the right to reject any or all quotations without specifying any reasons thereof.
7. 7. In case of delay, penalty at the rate of 0.5% per day of the ordered value shall be charged (maximum penalty up to 5 % of the order value can be deducted). If the delay is more than ten days the order shall stand cancelled.
