Subject : Indira Gandhi Matritva Sahyog Yojana (IGMSY)-Conditional Maternity Benefit (CMB) Scheme-release of 1st instalments of grants-in-aid to the UT Administration of Andaman & Nicobar Island during 2014-15.

The State Government will maintain separate records of expenditure incurred for implementation of Indira Gandhi Matritva Sahyog Yojana (IGMSY)-Conditional Maternity Benefit (CMB) Scheme and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

3. It is requested that a letter of Authority may be issued to Accounts officer, Pay & accounts office, Administration of Andaman & Nicobar Islands, Port Blair-744001 for drawing the amount from PAO, Ministry of Women & Child Development, New Delhi in accordance with prescribed procedure.
