The State Government of Sikkim will maintain separate records of expenditure incurred for implementation of Indira Gandhi Matritva Sahyog Yojana (IGMSY)-Conditional Maternity Benefit (CMB) Scheme and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

3. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.


