Key Features of Aadhaar:

- Only a random number – for life time, no smart card
- All residents – for children, transgenders
- Uniqueness: 1 person = 1 Aadhaar
- Minimal data collected
- Secured & Privacy of data ensured
- Ubiquitous online authentication
- Enroll & Update from anywhere
- Doesn't confer citizenship, rights, entitlements

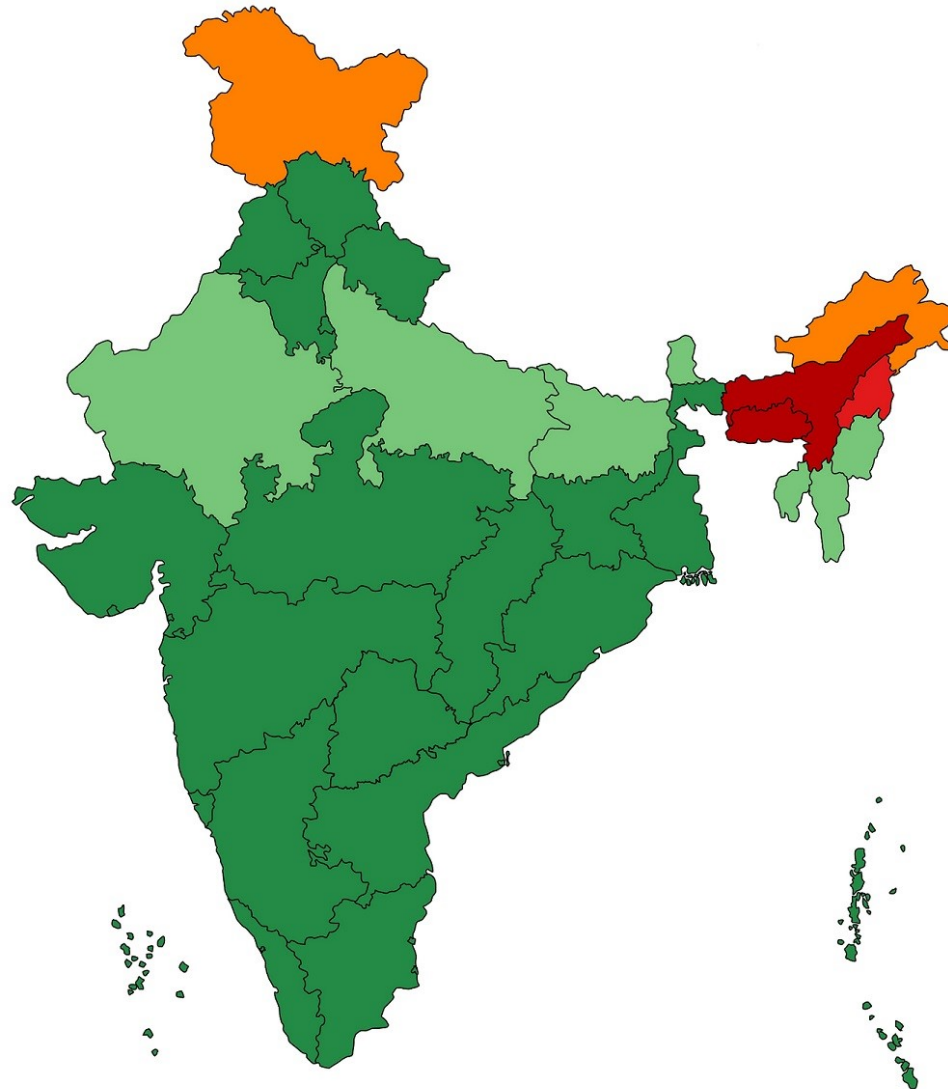

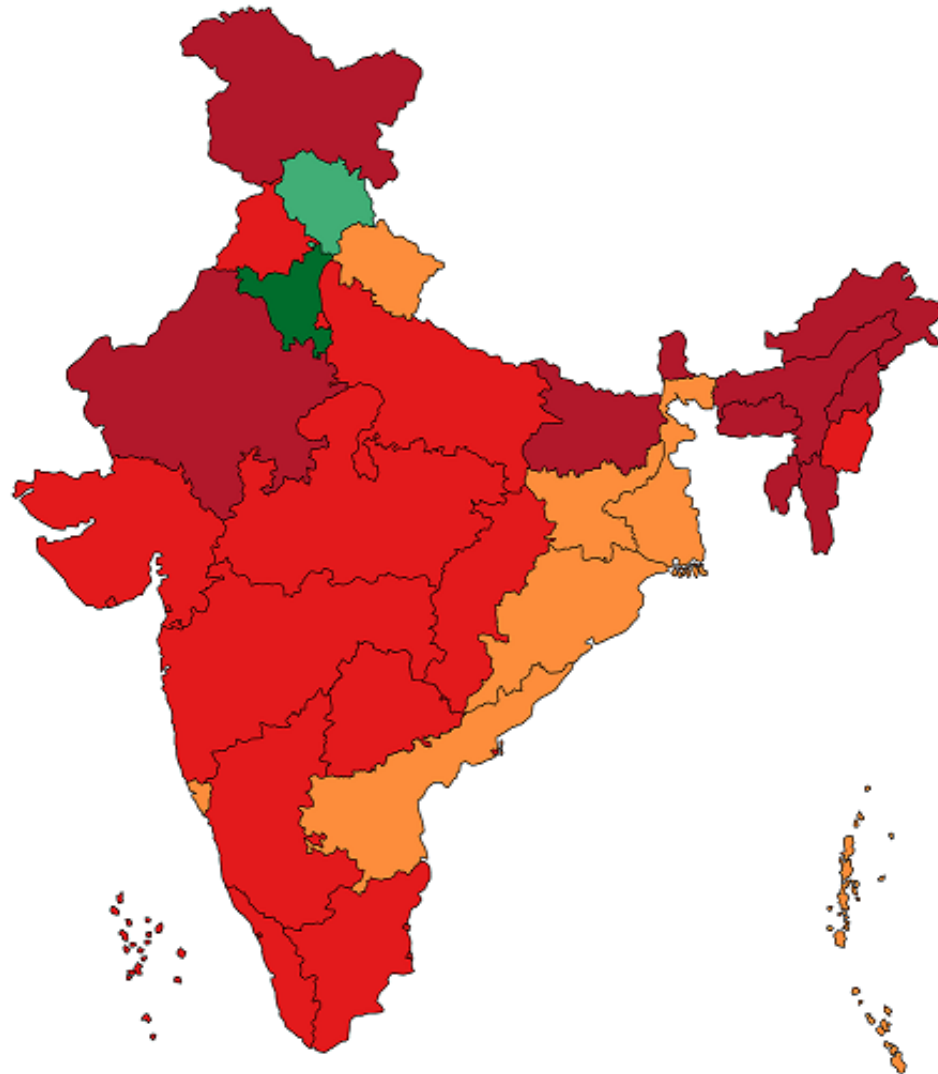

ENROLMENT

Regulation 12 of Aadhaar (Enrolment and Update) Regulations, 2016 states that *“Any Central or State department or agency which requires an individual to undergo authentication or furnish proof of possession of Aadhaar number as a condition for receipt of any subsidy, benefit or service pursuant to Section 7 of the Act, shall ensure enrolment of its beneficiaries who are yet to be enrolled or update their Aadhaar details, through appropriate measures, including co-ordination with Registrars and setting up enrolment centres at convenient locations or providing enrolment facilities by becoming a Registrar itself.”*



Enrolment Strategy

- Enrolment facility at Anganwadi
- Roster for enrolment kit rotation
- Training and certification of operators
- Rs 27 per enrolment of children
- Advance promotion to ensure maximum enrolments
- Advance list of children to be enrolled in the area
- Check with parents if children is already enrolled for Aadhaar
- Ensure no repeat enrolments

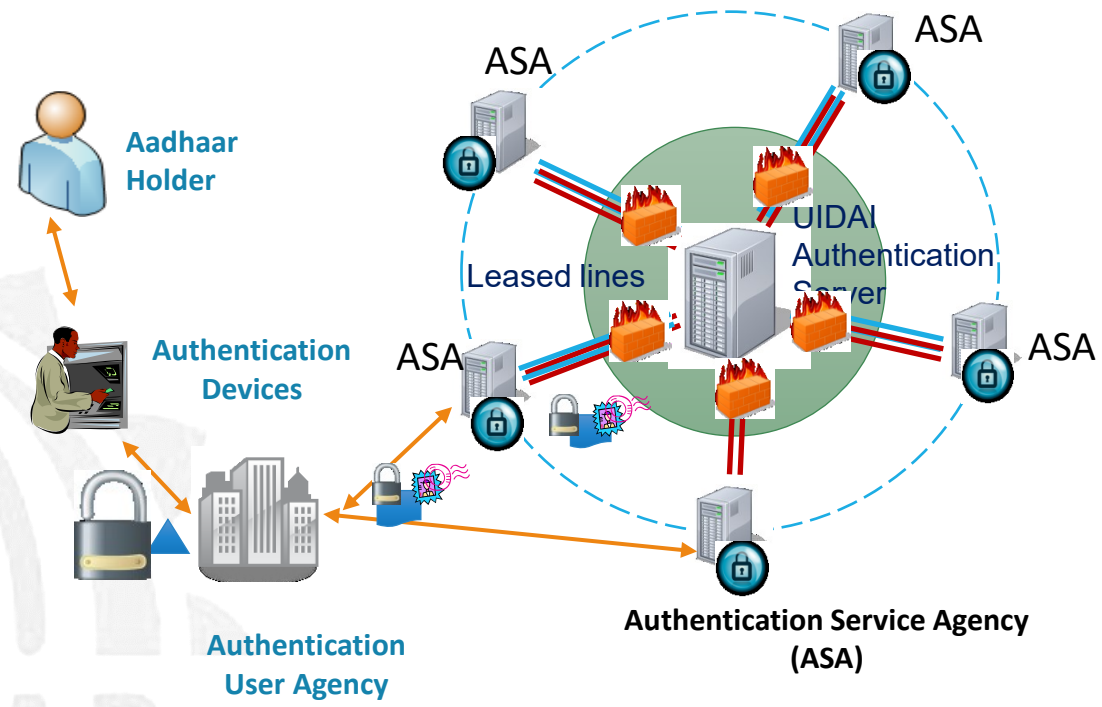

- UIDAI does not collect purpose, location or details of transactions
- 1,758 crore authentications performed; 483 Cr Aadhaar KYC transactions
- About 4 crore authentications per day
- The Auth/e-KYC transactions achieved peak authentication load of over 6 crores
- 307 AUAs including central Ministries, All Scheduled Commercial Banks, and Telcos
- PDS, MGNREGA, DBTL, AEPS, bank account, SIM cards, insurance, attendance, etc.



AADHAAR AUTHENTICATION

- Identity verification may be done using Yes/No Authentication or e-KYC
- One time authentication during registration OR authentication every time to avail benefit
- Informed consent as per Section 8 of Aadhaar Act, 2016
 - Aadhaar holder should clearly be made aware of the usage, the data being collected, and its usage
 - Consent in local language as well
- Allow multi-finger authentication after few tries
- Offer alternates such as Iris or OTP



AADHAAR AUTHENTICATION : Exception Handling

- i) UIDAI provides various modes of authentication viz demographic, biometric (fingerprint and Iris) and OTP. The requesting entity may provide authentication facility using any of the above modes of authentication.
- ii) In addition, as per Regulations 14(1) (i) of Aadhaar (Authentication) Regulations 2016, all requesting entities are required to implement exception-handling mechanisms and back-up identity authentication mechanisms to ensure seamless provision of authentication services to Aadhaar number holders.
- iii) [DBT Mission Cabinet Secretariat](#) had issued a detailed circular dated 19.12.2017 regarding Use of Aadhaar in Benefit Schemes of Government - Exception Handling



DOs and DONTs

- Full Aadhaar number display must be controlled only for special roles/users having the need within the department.
- By default, all Aadhaar number displays should be masked
- Identify and prevent any potential data breach or publication of personal data.
- Ensure swift action on any breach personal data.
- Ensure no Aadhaar data is displayed or disclosed to external agencies or unauthorized persons.
- Create internal awareness about consequences of breaches of data as per Aadhaar Act, 2016
- Ensure that officials understand the implications of the confidentiality and data privacy breach



DOs and DONTs

- Do not publish any personal identifiable data including Aadhaar in public domain/websites etc. Publication of Aadhaar details is punishable under Aadhaar Act, 2016
- Do not store biometric information of Aadhaar holders collected for authentication
- Do not print/display out personally identifiable Aadhaar data mapped with any other departmental data such as on ration card/birth certificate/caste certificate/any other certificate/document. Aadhaar number if required to be printed, Aadhaar number should be truncated or masked
- Do not capture/store/use Aadhaar data without consent of the resident as per Aadhaar act. The purpose of use of Aadhaar information needs to be disclosed to the resident.
