The undersigned is directed to inform you that POSHAN Abhiyaan was formally launched on 8th March, 2018. POSHAN Abhiyaan aims to reduce mal-nutrition from the country in a phased manner, through the life cycle concept, by adopting a synergized and result oriented approach. The Abhiyaan ensure mechanisms for timely service delivery and a robust monitoring as well as intervention infrastructure. Target of Mission is to bring down stunting of the children in the age group of 0-6 years from 38.4% to 25% by the year 2022.

- 2. One of the activities under the Abhiyaan is implementation of ICDS-Common Application Software under which all the States/UTs have to procure Smart Phones, Power Bank and Growth Monitoring Devices {Infantometer, Stadiometer, Weighing Scale (Infant) and Weighing Scale (Mother and Child)}. States/UTs have to also do other activities like organising Community Based Events, Incremental Learning training, Convergence Action Plan meeting, IEC & Advocacy etc.
- 3. Since POSHAN Abhiyaan is a beneficiary oriented scheme and the beneficiaries are among the most vulnerable sections of the society therefore, it becomes necessary that the activities related to the scheme are implemented in a unhindered manner so that benefits reach timely to the end beneficiary as time is perhaps the most important factor for the achieving the objective of the Scheme.
- 4. The States/UTs are at various stages of implementation of the schemes. Some of the States/UTs have stopped the process of procurement due to Model Code of Conduct.

- 5. Election Commission of India has given the permission to State of Madhya Pradesh vide letter dated 29.03.2019 (copy enclosed) for procurement of Smart-phones.
- 6. Since this is an ongoing Scheme, it is felt that the MCC may not be applicable and States/UTs can roll out the Scheme during MCC also as per the Scheme guidelines.
- 7. It is, therefore, requested to kindly clarify that the Model Code of Conduct for Lok Sabha Election 2019 will not be applicable for unhindered implementation of activities for the ongoing POSHAN Abhiyaan in the States/UTs and States/UTs may continue the process for procurement of devices etc. through GeM portal for continued roll-out of ICDS-CAS and regular Growth Monitoring.

Details on POSHAN Abhiyaan

Background:

- 1. It is a known fact that under nutrition is an outcome of not one but multiple detrimental factors. These factors play their role in helping sustain this continuous burden of under nutrition; leading to our inability to achieve our desired human resource potential, generation after another. In order to achieve its true potential and play the role as a global superpower India will need to focus on eradication of malnutrition so as to ensure that the coming generations are healthy, enabling higher intellectual potential, leading to enhanced work productivity.
- 2. On 8th March, 2018; Hon'ble Prime Minister launched POSHAN Abhiyaan PM's Overarching Scheme for Holistic Nourishment (National Nutrition Mission)from Jhunjhunu in Rajasthan. Overall budget is ₹ 9046 Crore. To ensure a holistic approach, all 36 States/UTs and districts have been covered. More than 10 crore people will be benefitted by this programme.

Goals:

3. The goals of POSHAN Abhiyaan are to achieve improvement in nutritional status of Children from 0-6 years, Adolescent Girls, Pregnant Women and Lactating Mothers in a time bound manner during the three years with fixed targets as under:

1.	Prevent and reduce Stunting in children (0- 6 years)	By 6% @ 2% p.a.
2.	Prevent and reduce under-nutrition (underweight prevalence) in children (0-6 years)	Ву 6% @ 2% р.а.

4.	Reduce the prevalence of anemia among Women and Adolescent Girls in the age group of 15-49 years.	By 9% @ 3% p.a.

- 4. The Abhiyaan aims to reduce mal-nutrition from the Country in a phased manner, through the life cycle concept, by adopting a synergised and result oriented approach. The Abhiyaan will ensure mechanisms for timely service delivery and a robust monitoring as well as intervention infrastructure. Target is to bring down stunting of the children in the age group of 0-6 years from 38.4% to 25% by the year 2022.
- 5. Details regarding the fund/budget allocated, expenditure is at Annexure.

Convergence:

6. Different Ministries/Departments at the Centre and States/UTs deal with varied interventions required for reduction of malnutrition in a stand-alone manner. POSHAN Abhiyaan

ensure convergence of various programmes i.e. Anganwadi Services, Pradhan Mantri Matru Vandana Yojana, Scheme for Adolescent Girls of Ministry of Women & Child Development; Janani Suraksha Yojana (JSY), National Health Mission (NHM) of MoH&FW; Swachh Bharat Mission of Ministry of Drinking Water & Sanitation (DW&S); Public Distribution System (PDS) of Ministry of Consumer Affairs, Food & Public Distribution (CAF&PD); Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) of Ministry of Rural Development (MoRD); Drinking Water & Sanitation with Ministry of Panchayati Raj; Ministry of Tribal Affairs and Urban Local Bodies through Ministry of Urban Development.

7. Ministry of Women and Child Development is the nodal Ministry for anchoring overall implementation; as described above, the vision is for all aligned Ministries to work together for addressing under nutrition. Never before has so many programs been pulled together for addressing under nutrition at national level in India. The Prime Minister reviews the progress every six months and similar review is expected at state level; and this process will be augmented by nutrition specific review in every district by the District Magistrate on a quarterly basis. Every state/district develops its Convergence Action Plan which includes their specific constraints and bottlenecks and what can they address in short, mid or long term. The Chief Secretary need to chair the Convergence Action Plan (CAP) meeting on quarterly basis. DC/DMs also need to take CAP meeting on quarterly basis.

Technology (ICDS-Common Application Software):

- 8. The Abhiyaan empowers the frontline functionaries i.e. anganwadi workers and Lady Supervisors by providing them with smartphones. The software application, ICDS-Common application Software especially developed for this purpose enables data capture, ensures assigned service delivery and prompts for interventions wherever required. This data is then available in near real time to the supervisory staff from Block, District, State to National level thorough a Dashboard, for monitoring. The procurement and distribution of mobile devices is a part of the project. The application is aimed to augment system strengthening in ICDS service delivery and looks at improving the nutrition outcomes through effective monitoring and timely intervention. CAS replaces ~8.2 kg of paper registers with 173 gms of smartphone. It enables growth monitoring of children with the help of auto plotting of growth chart on the mobile application; Autogenerates task list and home visit scheduler for enabling AWW to focus on the beneficiaries based on priority. System generated SMS alerts are sent to beneficiaries and government officials. It is aimed to improve the ICDS service delivery and also enable the Mission to effectively plan and take fact-based decision making. Predictive Analytics & Big Data Analyticsare being used to uncover hidden patterns, correlations and insights. Coverage and Roll-out of ICDS-CAS as on 30th April, 2019 is as under: -
 - (a) States/UT: 18
 - (b) Districts: 131
 - (c) Anganwadi Centres: 2,32,495
- 9. States/UTs are at various stage of procurement of smart phones. As on date only 3.89 lakh smart phones procured out of 15.30 lakh. Due to model code of conduct some States/UTs have stopped the process of procurement.

Community Mobilization, Behavioral Change and Jan Andolan:

- 10. Community Mobilization and Behavioral Change is another important component of the Abhiyaan. The Abhiyaan is focusing on converting the agenda of improving nutrition into a Jan Andolan through involvement of Panchayati Raj Institutions/Villages Organizations/SHGs/volunteers etc. and ensuring wide public participation. Accordingly, inter-Ministerial Guidelines on Jan Andolan have been developed and released, to build consensus, achieve convergence and synergise efforts towards achieving the desired Goals. States/UTs to carry out IEC activities on regular basis for which funds to the tune of Rs. 19.00 lakh per district per year has been already allotted to the States/UTs.
- Organization of Community Based Events (CBEs): In order to strengthen processes for community engagement, empowerment of beneficiaries and increased social accountability of ICDS, the POSHAN Abhiyaan provides for the organization of Community Based Events (CBEs) twice in a month on a fixed day of a week by each Anganwadi Centre. The processes under this component also encompass outreach visits by Aanganwadi Worker to prioritized households to promote Infant and Young Child Feeding (IYCF) practices; development of well-researched designed and tested communication plan & IEC materials and intensive Mass Media Campaign on Nutrition. Detailed Guidelines on conduct of CBE have been issued. Most of the States/UTs are conducting the CBEs regularly as per the guidelines.
- 12. Rashtriya Poshan Maah: September 2018 was celebrated as the Rashtriya Poshan Maah across the Country. A Dashboard to monitor all activities during the month was developed. Approximately 25 crore people had participated and more than 22 lakh activities were conducted across India.
- 13. **PoshanPakhwada:** PoshanPakhwada on the lines of Poshan Maah was celebrated across the Country as part of Jan Andolan under POSHAN Abhiyaan from 08th to 22nd March, 2019.

Capacity Building:

14. The Abhiyaan focuses on building the capacity of front-line ICDS functionaries in effective and consistent service delivery by using Incremental Learning Approach (ILA). Under ILA, functionaries are being trained on thematic modules following the cascade of training of State Resource Group (SRG), District Resource Groups (DRGs) and Block Resource Groups (BRGs). Total 21 ILA modules have been provided to the States/UTs. States/UTs have started rolling out ILA Modules. A digital version of ILA has also been developed. The frontline functionaries can learn using a mobile application and the progress can be monitored on the dashboard. ILA training are conducted regularly as per the guidelines.

Incentives:

15. There are performance based incentives linked at various levels. Anganwadi workers for minimum service delivery; team based incentives for Anganwadi workers, ASHA and ANM for achieving targets together; and for States and UTs.

Flexi Funds:

16. There is also a provision of Flexi Funds. 7% of total allocation to States/UTs under the scheme to be utilized towards Flexi activities. States/UTs are at various stage for finalisation of Flexi Funds.

Innovations:

17. States/UTs may choose any innovation pilot and scale it up as per requirement and progress. The norms for allocation of funds to States/UTs under the Innovation activities is @ ₹ 27.85 Lakhs per district for the entire duration of the project i.e. upto March, 2020. Most of the States/UTs have not yet prepared the innovation pilot.

Partnerships:

- 18. MoC with BMGF: A Memorandum of Cooperation (MoC) with the Bill & Melinda Gates Foundation signed on 20th May, 2016 for providing technical support for roll-out and development of ICDS-CAS and technical support on nutrition at the National and State level. The MoC was signed initially be for a period of three years upto 20 May, 2019. There was provision to extend the MoC for another two years. With mutual consent the MoC has been extended upto 20 May, 2021.
- 19. **MoU with TATA Trusts:** An MoU signed with Tata Trusts to deploy Swasth Bharat Preraks (SBP) across all Districts. As on date 310 Preraks are deployed on ground.
- 20. **MoA with NASSCOM Foundation:** MoA for technical as well administrative support for implementation and roll-out at State/UT level has been signed.

Sir,

The undersigned is directed to inform you that POSHAN Abhiyaan was formally launched on 8th March, 2018. POSHAN Abhiyaan aims to reduce mal-nutrition from the country in a phased manner, through the life cycle concept, by adopting a synergized and result oriented approach. The Abhiyaan ensure mechanisms for timely service delivery and a robust monitoring as well as intervention infrastructure. Target of Mission is to bring down stunting of the children in the age group of 0-6 years from 38.4% to 25% by the year 2022.

- 2. One of the activities under the Abhiyaan is implementation of ICDS-Common Application Software under which all the States/UTs have to procure Smart Phones, Power Bank and Growth Monitoring Devices {Infantometer, Stadiometer, Weighing Scale (Infant) and Weighing Scale (Mother and Child)}. States/UTs have to also do other activities like organising Community Based Events, Incremental Learning training, Convergence Action Plan meeting, IEC & Advocacy etc.
- 3. Since POSHAN Abhiyaan is a beneficiary oriented scheme and the beneficiaries are among the most vulnerable sections of the society therefore, it becomes necessary that the activities related to the scheme are implemented in a unhindered manner so that benefits reach timely to the end beneficiary as time is perhaps the most important factor for the achieving the objective of the Scheme.
- 4. The States/UTs are at various stages of implementation of the schemes. Some of the States/UTs have stopped the process of procurement due to Model Code of Conduct.

- 5. Election Commission of India has given the permission to State of Madhya Pradesh vide letter dated 29.03.2019 (copy enclosed) for procurement of Smart-phones.
- 6. Since this is an ongoing Scheme, it is felt that the MCC may not be applicable and States/UTs can roll out the Scheme during MCC also as per the Scheme guidelines.
- 7. It is, therefore, requested to kindly clarify that the Model Code of Conduct for Lok Sabha Election 2019 will not be applicable for unhindered implementation of activities for the ongoing POSHAN Abhilyaan in the States/UTs and States/UTs may continue the process for procurement of devices etc. through GeM portal for continued roll-out of ICDS-CAS and regular Growth Monitoring.
