I am directed to convey the sanction of the President to the payment of Rs.6.95 Lakh (Rupees Six Lakh and Ninety Five thousand only) to the following UT to the extent of amount indicated against each as grants-in-aid during 2017-18 towards GoI's share (100%) for the implementation of National Nutrition Mission under Ministry of Women & Child Development for the current financial year.

- 2. The State Government will furnish Utilization Certificate in respect of the grants-in-aid released as per the provisions contrained in GFR, 2017. Further, the State Government will maintain separate records of expenditure incurred for implementation of National nutrition Mission (NNM) and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure for the period 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July, for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October, from the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central Assistance of each State Government.
- 3. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole.
- 4. National Nutrition Mission is a scheme in which the Centre and States/ UTs both have contributions. In the above release, the Centre and States contributions have been calculated on 100 % at present. However, as the National Nutrition Mission would be an Externally Aided Project. This will be funded by Government Budgetary Support (50%) and 50% by IBRD or other MDB on approval. Government budgetary support would be 60:40 between Centre and States/UTs with legislature, 90:10 for NER and 3 Himalayan States (Uttarakhand, Jammu & Kashmir and Himachal Pradesh) and 100% for UTs without legislature. The actual funding from IBRD or other MDBs will follow the extant procedure, as prescribed by Department of Economic Affairs. The cost sharing ratio for IBRD or other MDB, Government of India, States & Union Territories will be as per the following Table:

- It is requested that a Letter of Authority may be issued to Accounts Office, Administration of Union Territory as in para-1 for drawing the amount from PAO, Ministry of Women & Child Development, New Delhi in accordance with the prescribed procedure.
- National Nutrition Mission would be an Externally Aided Project. This will be funded by Government 6. Budgetary Support (50%) and 50% by IBRD or other MDB on approval. Government budgetary support would be 60:40 between Centre and States/UTs with legislature, 90:10 for NER and 3 Himalayan States (Uttarakhand, Jammu & Kashmir and Himachal Pradesh) and 100% for UTs without legislature. The sanction of funds is subject to the following conditions: (Conditions to be changed)
  - The amount of grant will have to be utilized for all the components under the Scheme as per IV. the schematic norms;
  - The States/ UTs shall also be required to contribute adequate amount for implementation of V. the National Nutrition Mission;
  - All the devices shall be procured through GeM, the expenditure for procuring the devices by VI. the States/UTs shall be done as per schematic norms of NNM.
