- The State Government will furnish Utilization Certificate in respect of the grants-in-aid released as per the provisions contrained in GFR, 2017. Further, the State Government will maintain separate records of expenditure incurred for implementation of National nutrition Mission (NNM) and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure for the period 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central Assistance of each State Government
- The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole.
- National Nutrition Mission is a scheme in which the Centre and States/ UTs both have contributions. In 4. the above release, the Centre and States contributions have been calculated on 60:40 ratio at present. However, as the National Nutrition Mission would be an Externally Aided Project. This will be funded by Government Budgetary Support (50%) and 50% by IBRD or other MDB on approval. Government budgetary support would be 60:40 between Centre and States/UTs with legislature, 90:10 for NER and 3 Himalayan States (Uttarakhand, Jammu & Kashmir and Himachal Pradesh) and 100% for UTs without legislature. The actual funding from IBRD or other MDBs will follow the extant procedure, as prescribed by Department of Economic Affairs. The cost sharing ratio for IBRD or other MDB, Government of India, States & Union Territories will be as per the following Table:

- 5. National Nutrition Mission would be an Externally Aided Project. This will be funded by Government Budgetary Support (50%) and 50% by IBRD or other MDB on approval. Government budgetary support would be 60:40 between Centre and States/UTs with legislature, 90:10 for NER and 3 Himalayan States (Uttarakhand, Jammu & Kashmir and Himachal Pradesh) and 100% for UTs without legislature. The sanction of funds is subject to the following conditions: (Conditions to be changed)
 - IV. The amount of grant will have to be utilized for all the components under the Scheme as per the schematic norms;
 - V. The States/ UTs shall also be required to contribute adequate amount for implementation of the National Nutrition Mission;
 - VI. All the devices shall be procured through GeM, the expenditure for procuring the devices by the States/UTs shall be done as per schematic norms of NNM.
- 6. The expenditure is debitable to the '3602'- Grants-in-aid to Unoin Territory (Major Head); 06- Centrally Sponsored schemes (sub major head); 06.101- Central Assistance/ Share; 40- Umbrella ICDS; 40.03- National Nutrition Mission (NNM) EAP Component, 40.03.31- Grants-in-aid General under Demand No. 99 of the Ministry of Women & Child Development for the year 2017-18.
- 7. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State will be made through cheque in favour of The Secretary, Finance Department, Government of NCT of Delhi. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D-Wing, Ground Floor, New Delhi.
- 8. The pattern of grants has already been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Ministry of Finance.
- 9. This sanction issues with the concurrent of IFD vide their 49218 dated 22.03.2018.
