Action Point of Last EC Meeting

Monthly organisation of VHSND needs to be ensured at grass root level and Guidelines need to be updated incorporating new initiatives.

→ Instructions has been issued to all States/UTs to ensure timely conducting VHSND.

Provision for incentives to AWW for home visits akin to ASHA to be explored.

→ Incentives to AWW for home visits akin to ASHA may be worked out once the HBYC guidelines are implemented on field.

Provision for mobility of Lady Supervisor and AWW needs to be studied.

The draft of Jan Andolan Guidelines to be circulated to concerned Line Ministries and Members for feedback by 15-06-2018.



The Jan Andolan guidelines launched by Vice Chairman, NITI Aayog in the 2nd National Council Meeting and circulated to all States/UTs on 13-08-2018.

India Nutrition Report may be prepared by NIN under the technical guidance of an Advisory Group, which will include the two expert co-opted members of the National Executive Committee.

- A meeting was held under the Chairmanship of Secretary, MWCD on 27th August, 2018 regarding modalities for an Annual National Nutrition Report and to study best practices carried out across India.
- D.O. Letter issued on 20th September, 2018 to NIN.
- NIN is requested to design and send detailed proposal for **2019 POSHAN Abhiyaan Survey**. The time line for baseline survey is March 2019.


Joint Mother Child Protection Card (MHFW/MWCD) needs to be updated - supported by a common core guidebook and counselling tool.

The updated card released on 14th April, 2018 by MoHFW.

Monthly ECCE Day needs to be strengthened and guidelines revisited for building on POSHAN Abhiyaan. States/UTs have been sensitized for observing ECCE day at least one in a month.

States/UTs have been sensitized for observing ECCE day at least one in a month.

A Nutrition Resource e-network needs to be set up in States to support POSHAN Abhiyaan - linked to National /State Nutrition Resource Centres.



- States/UTs have been informed.
- NNRC being setup at CPMU.

Pilot on Cash Transfer In lieu of Take-Home Ration (THR) may be conducted immediately. The design of this Pilot and its evaluation plan using a randomized control trail may be finalized and carried out in consultation with NITI Aayog.

The Themes and List of activities to be carried out as part of Jan Andolan to be clearly spelt out in conjunction with NITI Aayog. The budget allocation for carrying out Jan Andolan activities to be clarified.

ICDS-CAS Dashboard being modified to include indicators for Pregnant Women & Lactating Mothers and children under (0-2 years)

- Under Process, 1st meeting held on 27th August, 2018
- NIN requested to design and send detailed proposal for 2019 POSHAN Abhiyaan Survey.
- Time line for baseline survey is March 2019.

Implemented

A physical verification exercise/Survey to identify genuine beneficiaries and weed out duplicate as well ghost beneficiaries to be carried out by all States/UTs in the next three months.

- D.O. Letter issued to all States/UTs on 8th August, 2018
- Matter being constantly followed up with States/UTs

NIN to work out modalities of disseminating the nutrition training module down to AWWs, ASHA and ANM in conjunction with MoW&CD.

- NIN have developed three Modules so far
 - Mother & Child Health
 - Basics of Nutrition
 - Anemia
- Further under development

A meeting to discuss and finalize the implementation plan, responsibilities and creative material for the National Nutrition Month to be held around 15th August, 2018.

POSHAN Maah observed during September 2018

A Common Software Application to be developed and piloted for jointly registering common beneficiaries of Health and ICDS (women and children) and recoding their health and nutrition related information by concerned field functionaries (ASHA, ANM and AWW) of both the Departments.

- Access to the disaggregated data of ICDS-CAS and its Dashboard to be made available to the State/UTs latest by 31st October 2018.
- A new version of Dashboard with modules for bar coded capture of THR and data analytics to be made available an December 2018.

- Process initiated and 1st meeting held on 27th June, 2018 and in principle both Ministries agreed for pilot using Common Application Software.
- 2nd meeting held on 14th September, 2018 - Mathura District as Pilot area has been identified.
- Pilot to conclude by March,2019.

- Application Programming Interface (API) for data sharing is being developed.
- Process initiated and 1st meeting held on 14th September, 2018.
- New version of ICDS-CAS proposed for release on 01st April, 2019.
