# Minutes of the Video Conferences (VCs) with States/UTs held at New Delhi from 10<sup>th</sup> April, 2018 to 13<sup>th</sup> April 2018

A meeting was held with all 36 States/UTs under the Chairpersonship of Secretary, MWCD at Shastri Bhawan, New Delhi from 10<sup>th</sup> to 13<sup>th</sup>April 2018, 3.00 to 5.00 p.m. 8-10 States per day, through Video Conferencing. The aim of the meeting was (i) to take feedback from the States/UTs towards the roll-out of POSHAN Abhiyaan, (ii) to review status of implementation of Pradhan Mantri Matru Vandana Yojana (PMMVY), (iii) to review the progress and to receive the feed back from the States/UTs under the Scheme for Adolescent Girls and (iv) Inputs for DBT and construction/upgradation of AWCs. List of the States/UTs participated in the meeting are at **Annexure-1**. At the outset the Chairperson welcomed all the members of the participating States/UTs.

### (i) Roll-Out of POSHAN Abhiyaan

- 2. A detailed presentation was given by MWCD on the updated status and implementation aspects of POSHAN Abhiyaan. State/UTs are provided format on power point presentation on which they are required to send the information regarding action point of their States/UTs. Presentations shown during the Video Conferencing are available on website of POSHAN Abhiyaan (<a href="http://icds-wcd.nic.in/nnm/home.htm">http://icds-wcd.nic.in/nnm/home.htm</a>) under the link "Review Meetings".
- 3. Joint Secretary MWCD & Mission Director, POSHAN Abhiyaan provided updated status of POSHAN Abhiyaan and informed that 1<sup>st</sup> Executive Committee meeting was held on 13<sup>th</sup> March 2018 and loan of USD 200 million from World Bank has been approved. He further, informed that first batch of 40 Swasth Bharat Preraks will be deployed by end April 2018. He also emphasised that on the occasion of Ambedkar Jayanti (14th April) this year, Gram Panchayats across the country will hold meetings to discuss on the Nutritional aspects and their implementation along with Health and Sanitation issues. Gram Panchayats to weigh the children and display in the Anganwadi centres. He informed to States/UTs regarding scaling up of the project to cover another 235 Districts as part of POSHAN Abhiyaan Phase II, for which the States/UTs need to plan accordingly as list of 235 districts to be covered in FY 2018-19 is under finalisation.
- 4. The following salient aspects were highlighted during the presentation regarding which States/UTs are required to take actions immediately and inform the CPMU:
  - a. Nomination of Nodal Officers (if not done).
  - b. Complete the process of selection of JPC (1/10 districts) on Deputation.
  - c. Initiation of process for hiring of contractual staff. Hiring of manpower on contractual basis (as per approved ToR), appointment of State/UT level Staff to be completed and SPMU to be made functional. This activity needs to be initiated on priority.
  - d. Opening of POSHAN Abhiyaan Budget Head & Fund allotment to District Level.
  - e. Conduct of day-long Orientation on POSHAN Abhiyaan at State level.

- f. Procurement of Smartphones, Tablets, Growth Monitoring Devices, SIM Cards and Data Plans. Prudence to be exercised while procuring 4G Data plans to ensure network connectivity and compatibility with the Smart-phones and Tablets specifications.
- g. States/UTs should calculate required quantities and procurement can also be done for 235 Districts of phase II. Placement of Supply Order should be on GeM Portal.
- h. Confirmation regarding translation of Mobile application in regional language (if applicable)
- i. Translation of Guidelines & Manuals (ICDS-CAS, ILA, CBE) in regional language (if applicable).
- j. States/UTs have been oriented about the process of training on ICDS-CAS Dashboard for different functionaries.
- k. States/UTs to notify the committees for convergence at State, District and Block as per Administrative Guidelines. States/UTs should ensure conducting of convergence meetings as per schedule.
- 1. CBE and VHSND should be included in the convergence at Village level by ensuring participation of ASHA, ANM and DAY-NRLM volunteers.
- m. Initiation of formation of State Resource Group, District Resource Group & Block Resource Group for conducting Incremental Learning Approach (ILA) training. The template of ILA schedule is provided in power point presentation.
- n. States/UTs to implement ILA training from the month of May, 2018.
- o. To organise the Community Based Events States/UTs are required to two formats given in the guidelines.
- p. State/UTs should ensure transfer of money for conducting events in advance. States/UTs can fix one date of the month for uniformity across the State. CBE and VHSND should be conducted separately.
- q. CBE should be conducted on monthly basis in all the AWCs. The target should be to implement the CBE from the month of April, 2018 only.
- 5. The Chairperson spurred all the States and UTs to start rollout of activities related to POSHAN Abhiyaan immediately and send the utilisation certificate to the Ministry.

#### (ii) Status of implementation of Pradhan Mantri Matru Vandana Yojana (PMMVY)

6. The Video Conferences for reviewing the status *inter alia* of implementation of Pradhan Mantri Matru Vanadna Yojana (PMMVY) were held from 10.04.2018 to 13.04.2018 under the chairpersonship of Secretary, MWCD. The Record of Discussion with respect to PMMVY is as follows:

In this respect, MWCD urged the States/UTs to take this scheme on priority and the performance around 28 <sup>th</sup> February 2018 is achieved again, sustained every day and target to improve on it.

12.	Reporting System issues	MWCD asked the States to send the emails to the address mentioned with all the details and screenshots. It was requested that only one problem is mentioned in one email and clearly describe the issue being faced for better resolution. Also, it was informed that Email should be the primary mode of reporting issues as tracking through other modes is a challenge for all stakeholders.

# 7. The following are some of the highlights of discussions with the States/UTs:

# (iii) To review the status of implementation and to receive the feed back from the States/UTs under Scheme for Adolescent Girls

- 8. Implementation of Scheme for Adolescent Girls was reviewed in the video conference meetings held with States from 10<sup>th</sup> April 2018 to 13<sup>th</sup> April, 2018. Agenda item for the meeting through video conference with States included Scheme for Adolescent Girls.
- 9. The purpose of the meeting was to review the progress under the scheme and to receive the feed back from the States/UTs on certain issues. A power point presentation was

made highlighting the salient features of the scheme, the financial progress under the scheme, the issues on which action to taken and feedback to be received from the States/UTs. Joint Secretary, Dr Rajesh Kumar provided updated status of the scheme and stressed upon the fact that States/UTs to ensure that the Scheme for Adolescent Girls is implemented for out of school adolescent girls of age 11-14 years. It was reiterated that Scheme for Adolescent Girls which was introduced in the year 2010 on pilot basis has been expanded in a phased manner and w.e.f 01.04.2018, Scheme for Adolescent Girls is Pan India for out of school adolescent girls of age 11-14 years and Kishori Shakti Yojana has been phased out.

- 10. He also highlighted the fact that the age group of 11 -14 year is a 2<sup>nd</sup> window of opportunity as during this period, the pubertal growth spurt for girls takes place, hence addressing the nutritional needs of girls during this period would help in improving their growth and nutritional status/BMI.
- 11. The States were requested to put concerted efforts on the focus area under the scheme which are Nutrition support, IFA supplementation, De-worming, measuring BMI, imparting life skill education, transition of girls to formal schooling and promoting menstrual hygiene. The funding pattern and the cost norms for Nutrition and Non- Nutrition component under the scheme were discussed. States/UTs were further informed that the financial progress under Nutrition and non nutrition component of the scheme and saving as on 01.04.2018 as per the record available with the Ministry has been shared with States/UTs with a request to report the utilization of funds during the year 2017-18 and also report the savings under SAG and KSY as on 01.04.2018 to enable the Ministry to process the releases for 2018-19. The Joint Secretary categorically informed the States/UTs that since KSY has ceased to operate w.e.f 01.04.2018, the savings under KSY as on 01.04.2018 to be reported by States/UTs to the Ministry and this amount would be utilized under SAG in 2018-19. The proposal for revalidation in case required for use of savings in the current financial year need to be sent to the Ministry by States/UTs.
- 12. Actions to be taken by the States/UTs and to send the feed back are:
  - a. To implement the scheme in accordance with the guidelines circulated to States/UTs
  - b. To conduct base line survey and send the information in prescribed format to enable the Ministry in assessing the requirement for nutrition under SAG
  - c. To report the savings under SAG and KSY as on 01.04.2018 to facilitate the Ministry for timely release of funds under the scheme.
  - d. Issue Notification w.r.t revision in cost norms of nutrition as revised cost norms will be applicable on issuance of such Notification be the State Government.
  - e. To assess the requirement of food grains under SAG and intimate the same to MWCD for taking the same with D/Food & Public Distribution.
  - f. Ensure timely submission of monitoring reports to MWCD through RRS-SAG.
  - g. Link the scheme with Aadhaar-DBT (benefit in kind i.e. nutrition under SAG).
  - h. Contact details at MWCD for scheme implementation and RRS-SAG were shared with a request to States/UTs to intimate the name of the counter part (Nodal Officer) at State level.

13. Letters have already been issued to States/UTs on the above and also posted on the website of the Ministry. The presentations made during the meeting are available on the website of the Ministry. States/UTs were requested to send their feedback at the earliest.

### (iv) Inputs for DBT and construction/upgradation of AWCs

- 14. During the video conference held with States/UTs, the percentage of Aadhaar seeding of beneficiaries of two DBT schemes Supplementary Nutrition Program of Anganwadi Services and Payment of honorarium to Anganwadi Workers and Helpers and status of pending UC for funds released for construction and upgradation of Anganwadi Centres during 2013-14, 2014-15 and 2016-17 was also discussed. During the presentation and discussion following issues were clarified:
- i. The percentage of Aadhaar seeding of beneficiaries of these two DBT schemes varied from 0% to 100%. Performance of States/UTs in implementation of DBT schemes are closely monitored by PMO and Cabinet Secretariat.
- ii. Both the two schemes are DBT on-boarded and States/UTs are required to report monthly progress by 7<sup>th</sup> of every month in the prescribed format already circulated. The formats are again attached and can also be downloaded from the Ministry's website wcd.nic.in → DBT → Revised Reporting Formats. The States/UTs were advised NOT to send Aadhaar details and Bank details in Excel sheet.
- iii. Data entry of beneficiaries of both schemes is to be done in the ICDS-RRS Portal using the login credentials already given. Special emphasis to be given on Aadhaar saturation and seeding of children.
- iv. Anganwadi Workers and Helpers are all adults and 99% of them may be having Aadhaar Number. All States/UTs should achieve 100% Aadhaar seeding of these functionaries in the ICDS-RRS by 30.4.2018.
- V. Payment of honorarium to Anganwadi Workers and Helpers is to be done through PFMS only in DBT mode.
- vi. The Section IV-B of the Monthly Reporting Format for reporting 'In kind' benefit transfer for Supplementary Nutrition Program may be **left BLANK**.
- vii. States/UTs to set up permanent Aadhaar Enrolment Centre in the office of CDPO and procure Aadhaar Enrolment Kits from GeM Portal (3 kits for each CDPO). Central share for procurement of the kits has been released to all States/UTs in December, 2017.
- viii. The Monthly Progress Report (MPR) of DBT schemes in the prescribed formats are to be be sent by email to concerned Divisions of the Ministry and also to <a href="mailto:smahapatra59@nic.in">smahapatra59@nic.in</a> and <a href="mailto:santosh.kr93@gov.in">santosh.kr93@gov.in</a> by 7<sup>th</sup> of every month.
  - ix. It was noted with concern that some States/UTs have not been able to utilize the grants released during 2013-14 and 2014-15 for construction and upgradation of AWCs. The grants are lying idle with the States/UTs, which may invite serious audit objections. The concerned

States/UTs were advised to take the matter seriously and expedite completion of construction and upgradation of AWCs. In case the UCs are not received by 30.6.2018, the Ministry would be constrained to seek refund of the money.

- X. For construction of AWCs in convergence with MGNREGS for which Central share was released during 2015-16 and 2016-17, UCs are pending from most of the States/UTs. Lack of coordination with PRIs resulted in non-allocation of Labour Budget and non-inclusion of construction of AWCs in the District Plan. States/UTs were advised to complete the same on priority.
- xi. Some States/UTs informed that they have completed construction/upgradation of AWCs and sent the UCs to the Ministry already. They were requested to resend the UCs by email to <a href="mailto:smahapatra59@nic.in">smahapatra59@nic.in</a> and <a href="mailto:ashwani.kumar@nic.in">ashwani.kumar@nic.in</a> immediately.
  - 15. The meeting ended with vote of thanks to the Chair.
