**Subject: Uploading of data of Anganwadi Services Scheme in Poshan Tracker and NeGD to look after entire technical work of Poshan Tracker at all levels – regarding.**

Sir/ Madam,

As you are aware that there are 14 lakhs Anganwadi Centre (AWCs) sanctioned by GOI across the country of which 13.87 lakh AWCs are operational in 7075 ICDS Projects sanctioned/operational as on 31.12.2020.

2. This Ministry has reviewed the status of rollout of POSHAN Tracker on 13.04.2021 with NeGD, MeiTy. During the meeting, it has been informed that 12 lakh AWC master data has been uploaded in POSHAN Tracker application software which has now been increased to 12.37 lakhs AWCs as on 12.05.2021. In POSHAN Tracker, each AWC has been assigned 11 digit unique code which comprises 2 digit for state code, 3 digit for district code, next 2 digit for project code, next 2 digit for sector code and 2 digit for AWC code so that various reports including ad-hoc reports at all levels viz. National, State, District, Project/Block and AWC can be generated and analysis at all levels can be done based on the reported data through AWW app. The status of

delivery of Services under Anganwadi Services Scheme at all levels in Poshan Tracker is available at portal <https://poshantracker.in>.


3. I am directed to say that the entire data of each AWC related to the Anganwadi Services Scheme including beneficiaries is required to be uploaded in Poshan Tracker by 31st May 2021 positively. All States/ UTs are required to furnish a certificate to this effect to the Ministry immediately. It is also to inform you that all allocations of food grains and the finalisation of AIPs for release of funds under SNP and AW Services General shall be released to the States/ UTs based on reported data of AWC in Poshan Tracker.

4. I am also directed to say that the NeGD has designed, developed and implementing the Poshan Tracker in the Country. NeGD is, therefore, looking after the entire technical work of Poshan Tracker application. NeGD will render all assistance to Central to State Project Management Units (PMUs) and below. Therefore, States/ UTs are directed not to deploy any manpower to handle this aspect of Poshan tracker so that the duplication of efforts is avoided. However, the SPMUs will continue to handle all other non-technical matters like Community activities, outreach, Jan Andolan etc as earlier.

In view of above, I request you to instruct necessary instructions to concerned officers to adhere to above guidelines/ directions and take necessary remedial action to implement the same in all AWCs by 31.05.2021.
