Madam,

In continuation of this Ministry's sanction of even number, dated 27th March, 2020, I am directed to convey the approval of the Ministry of Women & Child Development, Government of India for allocation of additional quantities of **12030 (Twelve Thousand & Thirty) MTs of Rice** for 2nd Quarter of 2020-21 to the State Government of **West Bengal** (over and above foodgrains allocated *vide* this Ministry's letter of even number, dated 27th March, 2020) under the **Wheat Based Nutrition Programme (WBNP)** and **National Food Security Act (NFSA)** at the subsidized price not exceeding **₹ 3/- per kg for Rice and ₹ 2/- per kg for Wheat** to meet the Supplementary Nutrition under the Anganwadi Services [Umbrella Integrated Child Development Services (ICDS) Scheme] during the **2nd quarter of the year 2020-21.**

2. The allocation of foodgrains is subject to the condition that the Government of West Bengal will ensure compliance of the extant provisions of the NFS Act and Supplementary Nutrition (under ICDS) Rules.
3. The terms & conditions mentioned in this Ministry's sanction of even number, dated 27th March, 2020 will remain unchanged.
