Dear Shri Sikri,

Kindly refer to our D.O. letter of even number dated 10th March, 2011 in which we had communicated the status of our proposal to set up 5000 Skill Development centers (SDCs) under PPP mode in the context of Rajiv Gandhi Scheme for Empowerment of Adolescent Girls 'SABLA'. This communication seems to have created an erroneous impression that till such time these SDCs under PPP mode start functioning, 'SABLA' scheme will face difficulties. This impression is not true at all.

The 'SABLA' scheme envisages convergence with Modular Employable Skills (MES) under the Skill Development Initiative (SDI) Scheme. As of now, 1255 modules based on MES have been approved and 6398 training centers are registered as Vocational Training Providers (VTPs). This provides huge option to the students in selecting occupation and training centers of their choice. Further, the VTPs may facilitate through providing guidance to the students in selecting their modules on the basis of region-wise employability prospects in different sectors.

Moreover, the SDI Scheme has an open option for introducing any new modules in accordance with the local / regional demand and accordingly, courses conducted in Anganwadi Centres, may be brought under the ambit of SDI Scheme and they can also be registered as VTPs provided they possess requisite facilities. The assessment & certification can be carried out as per scheme guidelines.

You may also instruct your field coordinators to obtain detailed information on registered VTPs and allotted modules from State Directors / Regional Directorate of Apprenticeship Training under DGE&T / DGE&T Headquarters. In case of any difficulty in implementation, Director General Employment & Training can be contacted directly. We assure our fullest cooperation for successful implementation of 'SABLA'.

Dear *Shri Joshi,*

Please refer to your D.O.letter No.6-13/2010-RGSEAG dated 12th January, 2011 sharing therein the operational guidelines framed for the implementation of the Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG)-SABLA. I would like to inform that establishment of Skill Development Centres (SDCs) in various States under National Skill Development Programme (NSDP) of this Ministry is at formulation stage and it may take considerable time. Therefore, to provide vocational training to adolescent girls under Modular Employable Skills (MES), you may kindly instruct your field coordinators who are implementing SABLA scheme to contact respective State Training Directorates or nearest Vocational Training Providers (VTPs) who are registered with the State Training Directorates to conduct training under MES. Government of India will keep providing financial as well as assessment and certification assistance to the trainees as provided under the scheme.
