
I am directed to convey the sanction of the President for payment of **Rs.49,70,000** /- (**Rupees Forty Nine Lakh Seventy Thousand only**) to the **Government of Arunachal Pradesh** as grants-in-aid for **Setting up Women Helpline in Arunachal Pradesh**, Arunachal Pradesh under Universalisation of Women Helpline Scheme. This amount includes Rs. 32,70,000 towards recurring grant for the **six month** period of the financial year 2015-2016 and an amount of Rs. 17,00,000 towards non recurring grant for **Setting up Women Helpline**.



6. This sanction issues with the concurrence of JS& FA vide their Dy. No. 1051 dated 4.08.2015.


