**Subject: Beti Bachao Beti Padhao (BBBP) Scheme - release of funds to Govt. of Daman & Diu during 2014-15.**

Madam/Sir,

I am directed to convey the sanction of the President to the payment of **Rs.13,81,000/- (Rupees Thirteen Lakh and Eighty One Thousand only)** to the **Government of Daman & Diu** as grants-in-aid for the period from 01.03.2015 to 31.03.2015 during the financial year **2014-15** for implementation of **Beti Bachao Beti Padhao (BBBP) Scheme in the district of Daman**. The amount of grant-in-aid includes cost of activities such as Inter-Sectoral Consultation/ meeting and meeting of State Task Force, Training & Capacity Building Sensitization programme, Innovation and Awareness generation Activities, Monitoring and Evaluation at State/District level and Sectoral activities of M/o Human Resource Development & M/o Health and Family Welfare in the district of Daman. 
