Subject: Grant of approval to Government of Gujarat for incurring an expenditure of Rs.38,24,640/- (Rupees Thirty Eight Lakhs Twenty Four Thousand Six Hundred & Forty only) for running 83 creches under the National Crèche Scheme for the 1st & 2nd quarter of FY 2019-20 .

Madam/Sir,

I am directed to refer to your letter No.ICDS/MWCD/Crèche/2019/814650 dated 25.09.2019 requesting to release grants for the 1st, 2nd, 3rd & 4th quarter of financial year 2019-20 for running 83 crèches under National Crèche Scheme for Children of Working Mothers and to say as under:

2. The proposal has been examined in the Ministry and approval is hereby conveyed for incurring an expenditure of **Rs. 38,24,640/- (Rupees Thirty Eight Lakhs Twenty Four Thousand Six Hundred & Forty only)** as per calculations below -

2. The fund sharing pattern amongst the Central Government, State Government and organisation/institution running the creches will be in the ratio 60:30:10 and sanction of funds is subject to the following conditions:

- i. The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- ii. The State Government/NGOs shall also be required to contribute their share for implementation of the National Creche Scheme.
- iii. State Government shall release funds only to the functional crèches. Unspent grants, if any, will be adjusted during the release of next instalment of grants.
- iv. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered on the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

3. The grant is further subject to condition that the State Govt. will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

4. In accordance with **Rule 236(1) of GFR, 2017**, the accounts of all Grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.

5. Details of progress of expenditure on National Crèche Scheme from 1st April to 30th September must be furnished by 15th October and for the period from 1st October to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

6. The expenditure of **Rs. 38,24,640/- (Rupees Thirty Eight Lakhs Twenty Four Thousand Six Hundred & Forty only)** may be incurred from the unspent balance amounting to **Rs.1,68,68,640/-** available with the State Government on account of grants released for the 4th quarter of 2016-17 & 1st quarter of 2017-18.
