Subject: Release of recurring grant-in-aid to Govt. of Sikkim for running 46 Crèches under the National Crèche Scheme for the Children of Working Mothers for the 1st, 2nd, 3rd, & 4th quarter of 2018-19.

I am directed to convey the sanction of President of India to the payment of **Rs. 55,78,880/- (Rupees Fifty Five Lakhs Seventy Eight Thousand Eight Hundred Eighty Only)** to the State Govt. of Sikkim as 1st, 2nd, 3rd & 4th Quarter grant-in-aid (80% Govt's share) for the 2018-19 for running 46 crèches under National Crèche Scheme for Children of Working Mothers as per details below:-

2. The fund sharing pattern among the Central Government, State Government and organisation/institution running the crèches will be in the ratio 80:10:10 and sanction of funds is subject to the following conditions:

- i. The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- ii The States/UTs/NGOs shall also be required to contribute their share for implementation of the National Crèche Scheme.
- iii Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.
