Subject: Reimbursement of grant-in-aid to the State Government of Haryana for 259 ICCW run creches under the National Crèche Scheme for the period 01.04.2016 to 31.12.2016 – Reg.

Madam/Sir,

I am directed to convey the approval for incurring an expenditure of **Rs.1,76,15,787/- (Rupees One Crore Seventy Six Lakhs Fifteen Thousand Seven Hundred and Eighty Seven only)** as reimbursement of grant-in-aid for 259 ICCW run creches under the National Crèche Scheme for the period 01.04.2016 to 31.12.2016 as per the following details:

* Grants have been sanctioned only for the first six months

2. The sanction of funds is in compliance of the Hon'ble Delhi High Court's order dated 23.05.2017 in W.P.No.11116/2015 and is subject to the following conditions:

- i. State Government is satisfied and shall certify that the demand for reimbursement is justified as per schematic norms
 - ii. State Government shall release funds only to those ICCW run crèches found functional for the period from 01.04.2016 to 31.12.2016.
 - iii. State Government shall release funds only to the extent of verified expenditure.
 - iv. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-PS portal and have furnished details of Unique ID from NGO-PS portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.
 - v. Efforts may be taken to recover/adjust the unspent balance, if any, with the concerned ICCW State Councils.
3. The grant is further subject to condition that the State Government will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate as per GFR.
4. The expenditure of **Rs.1,76,15,787/- (Rupees One Crore Seventy Six Lakhs Fifteen Thousand Seven Hundred and Eighty Seven only)** may be incurred from the unspent balance remaining with the State Government for the 4th quarter of 2016-17 & 1st quarter of 2017-18.
5. This sanction issues with the concurrence of IFD vide their e-office Computer **No.28372 dated 23.03.2018.**
