**Subject: Reimbursement of grant-in-aid to the State Government of Himachal Pradesh for 111 ICCW run creches under the National Crèche Scheme for the period 01.04.2016 to 31.12.2016 – Reg.**


Madam/Sir,

I am directed to convey the approval for incurring an expenditure of **Rs.34,95,966/- (Rupees Thirty Four Lakhs Ninety Five Thousand Nine Hundred and Sixty Six only)** as reimbursement of grant-in-aid for 111 ICCW run creches under the National Crèche Scheme for the period 01.04.2016 to 31.12.2016 as per the following details:

1.	Honorarium to a Crèche worker	Rs.3000/- p.m.	Rs. 2700/- p.m.	Rs. 300/- p.m.
2.	Honorarium to a Crèche helper	Rs.1500/- p.m.	Rs. 1350/- p.m.	Rs. 150/- p.m.

2. The reimbursement of funds is in compliance of the Hon'ble Delhi High Court's order dated 23.05.2017 in W.P.No.11116/2015 and is subject to the following conditions:

- i. State Government shall release funds only to those ICCW run crèches found functional for the period from 01.04.2016 to 31.12.2016.
- ii. State Government shall release funds only to the extent of verified expenditure.
- iii. State Government shall release funds directly to the NGOs running creches

- iv. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-PS portal and have furnished details of Unique ID from NGO-PS portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.
- v. Efforts may be taken to recover/ adjust the unspent balance, if any, with the concerned ICCW State Councils.
3. The grant is further subject to condition that the State Government will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.
4. The expenditure of **Rs.34,95,966/- (Rupees Thirty Four Lakhs Ninety Five Thousand Nine Hundred and Sixty Six only)** may be incurred from the unspent balance remaining with the State Government on account of the grants released for the 4<sup>th</sup> quarter of 2016-17 & 1<sup>st</sup> quarter of 2017-18.
