Subject: Release of funds to the Hyderabad District of Telangana during 2017-18 under Beti Bachao Beti Padhao (BBBP) Scheme – reg.

Madam/Sir,

I am directed to convey the sanction of the President to the payment of Rs. 11,32,149/- (Rupees Eleven Lakh Thirty Two Thousand One Hundred Forty Nine only) to the Hyderabad District of Telangana as grants-in-aid as Ist instalment (of six months) during the financial year 2017-18 for implementation of Beti Bachao Beti Padhao (BBBP) Scheme.

2. An amount of Rs 26.90736 lakh (Rupees twenty six lakh ninety thousand seven hundred thirty six only) was revalidated to Hyderabad District in the F.Y. 2016-17 for implementation of BBBP Scheme. Out of this Rs 6.72385 lakh was utilised by the district and Rs. 20.18351 lakh left unspent with district. The same has been revalidated as per the request vide this Ministry's letter of even no. dated 23.06.2017 for utilisation during F.Y. 2017-18 for implementation of BBBP Scheme.

3. Thus, the total amount of Rs. 31.505 lakh (Rs. 11.32149 lakh released + Rs. 20.18351 lakh revalidated) is available with the District of Hyderabad for carrying out the planned activities under Beti Bachao Beti Padhao (BBBP) Scheme during the financial year 2017-18. The component wise maximum ceiling of expenditure is as under:


6. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

7. The expenditure is debitible to the 2235 – Social Security and Welfare (Major Head); 02 – Social Welfare (Sub Major Head); 02.103 – Women’s Welfare (Minor Head); 70 – Mission for Empowerment and Protection for women; 09 – Beti Bachao Beti Padhao Campaign; 70.09.31 – Grants-in-aid General in Demand No. 99 Ministry of Women and Child Development 2017-18.

8. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the Hyderabad District of Telangana would be arranged through NEFT/ECS. The State Accountant General/Deputy Commissioner will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.

9. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
