In supersession of earlier sanction of even number dated 7.09.2020, I am directed to convey the sanction of President of India to the payment of Rs. 6,39,14,083/- (Rupees Six crore Thirty Nine lakhs Fourteen thousand eighty three only) to the UT Govt. of Jammu & Kashmir grant-in-aid (80% Gol's share) for the year 2019-20 for running 606 crèches under National Crèche Scheme for Children of Working Mothers as per details below:

As per **Statement of component-wise actual expenditure certified/verified by the UT Govt. of J&K** the actual Central Share of pending liabilities for 606 reported functional Creches is indicated as **Rs. 6,60,03,043/-** which is less than the grant calculated as per the scheme guidelines. UT govt. of J&K has also confirmed that amount of Rs. Rs 20,88,960/- is remain unspent..

After adjusting the unspent balance of Rs 20,88,960 the total amount considered to be released is comes to **Rs 6,39,14,083/-** (Rs. 6,60,03,043 - Rs.20,88,960)

- 2. The fund sharing pattern among the Central Government, UT Government and organisation/institution running the crèches will be in the ratio 80:10:10 and sanction of funds is subject to the following conditions:
 - i. The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
 - ii. The UT Government/NGOs shall also be required to contribute their share for implementation of the National Creche Scheme.
- iii. UT Government shall release funds only to the functional crèches. Unspent grants, if any, will be adjusted during the release of next instalment of grants.
- iv. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered on the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.
- v. The accounts of all Grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPO) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so, in terms of the provisions contained in Rule 236(1) of GFRs, 2017
- 3. The grant is further subject to condition that the UT Govt. will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.
- 4. Details of progress of expenditure on National Crèche Scheme form 1st April to 30th September must be furnished by 15th October and for the period from 1st October to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.
- 5. The expenditure of **6,39,14,083/-** (Rupees Six crore Thirty Nine lakhs Fourteen thousand eighty three only) is debitable to the 3602 -Grants-in-aid to Union Territory Governments with legislature, (Major Head), 06-Centrally Sponsored Schemes (Sub Major Head), 101-Central Assistance/Share (Minor Head), 40-Integrated Child Development Services (Umbrella ICDS), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.100, Ministry of Women & Child Development 2020-21 (Plan).
- 6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of UT Government of J&K would be arranged through Reserve Bank of India, Nagpur.
