**Subject: Release of recurring grant-in-aid to Govt. of Jammu & Kashmir for running 670 Crèches under the National Crèche Scheme for the Children of Working Mother-regarding.**

Madam/Sir,

I am directed to convey the sanction of President of India to the payment of **Rs. 4,11,64,800/- ((Rupees Four Crore Eleven Lakhs Sixty Four Thousand Eight Hundred Only) to the State Govt. of Jammu & Kashmir as 1<sup>st</sup> & 2<sup>nd</sup> quarter** grant-in-aid (80% Govt's share) for the year 2018-19 for running 670 crèches under National Crèche Scheme for Children of Working Mothers.

2. The fund sharing pattern among the Central Government, State Government and organisation/institution running the crèches will be in the ratio 80:10:10 and sanction of funds is subject to the following conditions:

- i. The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- ii. The States/UTs/NGOs shall also be required to contribute their share for implementation of the National Crèche Scheme.
- iii. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

3. The grant is further subject to condition that the State Govt. will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

4. Details of progress of expenditure on National Crèche Scheme from 1st April to 30th September must be furnished by 15th October and for the period from 1st October to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

5. The expenditure of **Rs. 4,11,64,800/- (Rupees Four Crore Eleven Lakhs Sixty Four Thousand Eight Hundred Only)** is debit to the 3601 -Grants-in-aid to State Governments, (Major Head), 06-Centrally Sponsored Schemes (Sub Major Head), 101-Central Assistance/Share (Minor Head), 47-ICDS (Sub-Head), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.98, Ministry of Women & Child Development 2018-19 (Plan).

7. This sanction issues with the concurrence of IFD vide their e-office Computer No. 51353 dated 31.12.2018.


