- The expenditure of Rs.11,49,600/- (Rupees Eleven Lakhs Forty Nine Thousand ix Hundred only) is debitable to the 3601-Grants-in-aid to State Governments, (Major lead), 06-Centrally Sponsored Schemes (Sub Major Head), 101-Central Assistance/Share Minor Head), 47-ICDS (Sub-Head), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.100, Ministry of Women & Child levelopment 2020-21 (Plan).
