# Monthly Summary Report for the month of July, 2021 in respect of Ministry of Women & Child Development

The significant events relating to the work of Ministry of Women and Child Development for the month ending July, 2021 are as follows:

## 1. Legislative Agenda

- (i) The Juvenile Justice (Care and Protection of Children) Amendment Bill, 2021 which was passed by Lok Sabha during the Budget Session has been passed by Rajya Sabha on 28th July, 2021.
- (ii) The Indecent Representation of Women (Prohibition) Amendment Bill, 2012, was withdrawn by Hon'ble Minister of Women and Child Development.

#### 2. PM CARES Fund to children in distress due to COVID-19

A Portal for PM CARES for Children, i.e., pmcaresforchildren.in has been launched on 15th July 2021. A web meeting with States/UTs was also chaired by Secretary, WCD on the same day to introduce the Portal for PM CARES for children scheme. A web meeting was earlier held on 13th July, 2021 and to discuss facilities being provided by concerned Ministries in respect of PM CARES for Children. The guidelines for the scheme are being finalized and States/ UTs are populating the portal with data of Children orphaned due to COVID-19.

# Measures to ensure safety and well-being of Women & Children in view of spread of COVID-19:

Daily/ Weekly review of COVID-19 situation is being undertaken in MWCD institutions like One Stop Centres (OSCs), Swadhar Homes, Working Women Hostels (WWHs), Child Care Institutions (CCIs) etc. States / UTs are submitting Daily/ Weekly Report regarding welfare and protection of women and children residing in these institutions. Hon'ble Minister, MWCD reviews the situation on a weekly basis.

#### Pradhan Mantri Matru Vandana Yojana (PMMVY):

During the month of July, 2021 about 4.26 lakh beneficiaries were enrolled. About 10.90 lakh applications were entered on Pradhan Mantri Matru Vandana

Yojana-Common Application Software (PMMVY-CAS) portal. About Rs. 116.78 crore of maternity benefits was disbursed.

As on 01.08.2021, about 2.33 crore beneficiaries were enrolled; about 2.03 crore beneficiaries were paid maternity benefits; about 6.18 crore applications were entered on PMMVY-CAS; about 5.41 crore applications were paid and about Rs. 8840.07 crore of maternity benefits were disbursed under the scheme.

### 5. One Stop Centres and Women Helpline

704 One Stop Centres (OSCs) reported to be operational in 35 States/UTs have been functioning during Covid lockdown period to provide medical support, psycho-social counseling, police facilitation, legal counseling/ help, temporary shelter to women affected by violence, including domestic violence. Further, Women Help Lines are functional in 34 States and UTs for providing emergency and non-emergency telephonic support to women facing violence or difficult situations during the lock down period.

# 6. Shanghai Cooperation Organization (SCO) Forum on Women's Education and Poverty Reduction

The Ministry of Women & Child Development participated (in virtual mode) in the Shanghai Cooperation Organization (SCO) Forum on Women's Education and Poverty Reduction held on 20th July, 2021.

# Indian Ocean Rim Association (IORA) Working Group on Women's Economic Empowerment

The Ministry of Women & Child Development participated (in virtual mode) in the meeting of Indian Ocean Rim Association (IORA) Working Group on Women's Economic Empowerment (WGWEE) held on 22<sup>nd</sup> July, 2021 to discuss the IORA Action Plan 2017-21.
