Monthly Summary Report for the month of December, 2021 in respect of Ministry of Women & Child Development

The significant activities undertaken by Ministry of Women and Child Development for the month ending December, 2021 are as follow

1. The Prohibition of Child Marriage (Amendment) Bill, 2021: Within a short period of 15 days, the Ministry drafted "the Prohibition of Child Marriage (Amendment) Bill, 2021"; got it approved by the Cabinet; and the same was introduced in Lok Sabha by Hon'ble Minister. The bill proposes to increase the age of marriage for women from 18 years to 21 years to make it equal with that of men. The Bill has been referred to the Standing Committee.

2. National Conference on Women Winning against Tuberculosis (16.12.2021): Tuberculosis remains a public health challenge worldwide; furthermore, studies suggest that women are less likely to seek care for TB symptoms than their male counterparts. Societal constraints restrict women affected by TB from freely accessing prompt and continued care. This affects their role as caretakers and prevents prioritization of their nutrition, health, and well-being.

Recognizing this concern, Ministry of Women and Child Development along with Ministry of Health and Family Welfare organized a National Conference on Tuberculosis on December 16, 2021, at Vigyan Bhawan, New Delhi. Hon'ble Vice President Shri M. Venkaiah Naidu was the Chief Guest at the National Conference. Union Ministers for WCD and Health and Family Welfare, Smt Smriti Irani and Shri Mansukh Mandaviya, and Ministers of State for WCD and HFW Shri Munjapara Mahendrabhai and Dr. Bharati Pravin Pawar also participated in the event. The event was attended by over a thousand delegates, including MPs, Ministry and State representatives, TB Champions, Development Partners, Academics, Experts and Media. As a first, over 150 Anganwadi workers also joined the audience.

A key highlight of the Conference was experience sharing by two women TB survivors, who spoke about their challenges as TB patients, and also how the government system supported them through their treatment period.

3. Special Campaign to dispose of pending references: The Ministry and its all Autonomous Bodies/ Attached Offices are conducting Swachhta Abhiyaan every week on Wednesday from 05.00 p.m. to 08.00 p.m. As a special initiative to ensure timely resolution of grievances forwarded to the States/UTs, this Ministry has started joint Video Conferences in the afternoon of every Wednesday with different zones of the country. During the month of December, 2021, 2 such video conferences have been held on 22.12.2021 and 29.12.2021.

4. Hon'ble Minister, WCD participated in the Alumni event for trainees hosted by Embassy of Israel on 09.12.2021 as a Keynote Speaker and delivered a talk on Women's Empowerment.

5. On 22.12.2021, the Ministry participated virtually in the G20 EMPOWER and W20- 'G20 Women's Empowerment Kick-off Meeting' organized by the G20 Indonesian Presidency.
