**Subject: Release of recurring grant-in-aid to Govt of NCT Delhi for running 85 crèches under the National Crèche Scheme for the Children of Working Mothers—regarding.**

Madam/Sir,

I am directed to convey the sanction of President of India to the payment of **Rs.62,22,400/- (Rupees Sixty Two lakhs Twenty two thousand four hundred only )** to the **Govt. of NCT Delhi as 1<sup>st</sup> quarter to 4<sup>th</sup> quarter** grant-in-aid (90% Govt's share) for the year 2018-19 for running 85 crèches under National Crèche Scheme for Children of Working Mothers.

2. The fund sharing pattern between the Central Government and organisation/institution running the crèches will be in the ratio 90:10 and sanction of funds is subject to the following conditions:

- i. The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- ii. The State/UTs shall also be required to contribute their share for implementation of the National Crèche Scheme.
- iii. Unspent grants, if any, will be adjusted during the next release of grant.
- iv. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

3. The grant is further subject to condition that the UT Administration will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

4. Details of progress of expenditure on National Crèche Scheme from 1<sup>st</sup> April to 30<sup>th</sup> September must be furnished by 15<sup>th</sup> October and for the period from 1<sup>st</sup> October to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry of work out the entitlement of Central assistance of each State Government/UT Administration.

Rs.62,22,400/- (Rupees Sixty Two lakhs Twenty two thousand four hundred only)** is debitable to the 3602 -Grants-in-aid to Union Territory Governments (Major Head), 06-Centrally Sponsored Schemes (Sub Major Head), 101-Central Assistance/Share (Minor Head), 40-Umbrella ICDS (Sub-Head), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.98, Ministry of Women & Child Development 2018-19 (Plan).

6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. **The payment of the UT Administration would be arranged through Reserve Bank of India, Nagpur.** The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.
