I am directed to convey the sanction of the President for payment of **Rs.49,78,000 /-** (Rupees **Forty Nine Lakh Seventy Eight Thousand only**) to the Government of NCT of Delhi as grants-in-aid for **Setting up Women Helpline at New Delhi, NCT of Delhi** under Universalisation of Women Helpline Scheme. This amount includes Rs. 32,28,000 towards recurring grant for the six month period of the financial year 2015-2016 and an amount of Rs. 17,50,000 towards non recurring grant for **Setting up Women Helpline**.
