Subject: Allocation of additional/balance quantity of foodgrains (Rice & Wheat) under Wheat Based Nutrition Programme (WBNP) and National Food Security Act (NFSA), 2013 to meet the Supplementary Nutrition under the Anganwadi Services [Umbrella ICDS Scheme] during the 1st and 2nd quarter of the year 2019-20 – Reg.

Sir,

In continuation of this Ministry's sanction of even number, dated 6th September, 2019, I am directed to convey the approval of the Ministry of Women & Child Development, Government of India for allocation of additional/balance quantities of **9466 MTs of Wheat** (4733 MTs each for 3rd & 4th quarter) and **7100 MTs of Rice** ((3550 MTs each for 3rd & 4th quarter) to the State Government of **Chhattisgarh** (over and above foodgrains allocated *vide* this Ministry's letter of even number, dated 6th September, 2019) under the **Wheat Based Nutrition Programme (WBNP) and National Food Security Act (NFSA)** at the subsidized price not exceeding ₹ 3/- per kg for Rice and ₹ 2/- per kg for Wheat to meet the Supplementary Nutrition under the Anganwadi Services [Umbrella Integrated Child Development Services (ICDS) Scheme] during the 3rd & 4th quarter of the year 2019-20.

2. The allocation of foodgrains is subject to the condition that the Government of Uttar Pradesh will ensure compliance of the extant provisions of the NFS Act and Supplementary Nutrition (under ICDS) Rules.
3. The terms & conditions mentioned in this Ministry's sanction of even number, dated 6th September, 2019 will remain unchanged.
