Dear

This is with reference to the Video-conference held on 24.01.2018 with States/UT with regard to the launch the Phase -1 i.e. the beneficiary module of the Rapid Reporting System for the Scheme for Adolescent Girls - a web based on line monitoring for the Scheme for Adolescent Girls to facilitate the monitoring of the scheme and taking corrective measures by ensuring faster flow of information, accurate targeting of the beneficiaries and reduction of leakages. This Portal has been developed in collaboration with National Informatics Centre (NIC). **The URL for the portal is <http://sag-rrs.nic.in>**

2. The Government on 16.11.2017, realizing the multi-dimensional needs of out of school adolescent girls (11-14 years) especially the second growth spurt during this period and with a aim to motivate these girls to join school system, approved continuation of the Scheme for Adolescent Girls (SAG) for out of school girls in the age group of 11-14 years. The Scheme aims at providing them nutritional support @ Rs.9.50/beneficiary/day for 300 days in a year, motivating out of school girls to go back to formal schooling or skill training under non-nutrition component of the Scheme. Government has also approved expansion and universalisation of the Scheme for Adolescent Girls in a phased manner i.e. in additional 303 districts in 2017-18 and the remaining districts in 2018-19 with the simultaneous phasing out of Kishori Shakti Yojana.

3. States/UTs are requested to send the report under Scheme for Adolescent Girls through **<http://sag-rrs.nic.in>**. Login and Pass word being used under RRS-ICDS would be used to login for this URL also. A help desk has been set up at MWCD to assist the States/UTs to send the online report under Scheme for Adolescent Girls. The id of the help desk is **support-sagrrs@gov.in**. User manual for the portal will posted on the website of the Ministry shortly.

4. States/UTs are requested to ensure that the reports from January, 2018 are to be sent through sag-rrs for Scheme for Adolescent Girls. The first report under the scheme for the month of January, 2018 to be submitted to the Ministry positively by 15.02.2018 and thereafter regularly by 10<sup>th</sup> of every following month.
