Subject: Revised Allocation of food grains to the State of Uttar Pradesh under Wheat Based Nutrition Program (WBNP) to meet the Supplementary Nutrition under the Anganwadi Services (ICDS) Scheme during the 2nd quarters for FY-2021-22 – reg.

Sir/Madam,

In continuation of earlier **Sanction Order dated 26th Jul, 2021(copy enclosed)** for the allocation of food grains for the 2nd quarter, I am directed to convey the revised allocation of food grains approved by the Ministry of Women & Child Development Government of India **for total allocation of 55461 MTs of Fortified Rice in lieu of 55461 MTs of Normal Rice** to the State Government of Uttar Pradesh for the **2nd Quarter of the Financial Year i.e. 2021-22**, under Wheat Based Nutrition Programme(WBNP) at the subsidized price not exceeding at 3/- per kg for Rice and 2/- per kg for Wheat.

2. The State government may be allowed to lift fortified rice only in case the State has not lifted the normal rice allocated to them during the 2nd quarter vide sanction order 26th July 2021.

3. The cost of food grains shall be payable by the State Governments/UT Administrations to the Food Corporation of India (FCI).As per this Ministry's letter No. CD-II-22/4/21-CD-II dated 15/04/2021 the additional incremental cost for Fortification of Rice has been worked out to be 0.73 per kg. Therefore, State/UTs are informed that the additional incremental cost arising on account of fortification of rice shall be absorbed within the existing allocation under SNP by them.

4. The Government of Uttar Pradesh is requested to ensure to deposit the cost and lift the quantity of 55461 MTs of Fortified Rice allocated for the 2nd quarter of the year 2021-22 by 15th Oct, 2021.


5. The other terms and condition will be the same as mentioned in the earlier sanction order dated 26th July 2021.
