## **Internship Programme for Women Students / Scholars / Social Activists / Teachers**

This is in reference to the advertisement dated 31.01.2024 for two months Internship Programme of March-April 2024 Batch (01.03.2024-30.04.2024). Applications were invited from women students/scholars/social activists/teachers from Non-Tier I cities and rural parts of India for Internship Programme for two months' duration [01.03.2024-30.04.2024].

- 2. In this regard, it is informed that the aforementioned **advertisement dated 31.01.2024 stands cancelled and all the candidates who had applied before are requested to apply again**. The aspiring candidates should be from the age group 21-40 years for the Internship Programme and need to be enrolled in/associated with any university/academic/non-academic institution.
- 3. The candidates have to apply by sending scanned copy of duly filled self-attested form (attached below) along with supporting documents (*Id Proof/ Address Proof/Marksheet/Joining letter of institution- only for teachers/social activists*). Further, candidates are also required to fill the information in the excel sheet (attached alongside advertisement). **Candidates should send self-attested form along with supporting documents and duly filled excel sheet only through email at the ID <mwcd-research@gov.in>. The last date of receiving applications is 18.02.2024, 05:00 PM.**
- 3. This programme is meant to help in orientating the women students/scholars/social activists/teachers (hereinafter termed as 'interns') with the policies and programmes of the Ministry by offering short-term association. The interns may be required to undertake pilot projects/micro-studies focusing on the ongoing activities of the Ministry. The Ministry endeavours from this activity, a qualitative exposure of the interns to its mandate, specific programmes and policy analysis so as to make them proactive to raise the issues of women and children on various platforms in future.
- 4. Selection of the interns would be made on the basis of recommendations of the Selection Committee duly constituted for this purpose. The list of recommended candidates shall be available on the Ministry's website under 'What's New'. A candidate once selected for the Internship Programme, shall not be eligible for applying again.

- 5. Selected interns would be granted a lump sum stipend of Rs. 20,000/- per month and reimbursement of travel cost (by deluxe / AC bus / 3 Tier AC train) of the journey for joining the programme in the Ministry and return at the end of the programme. Willing interns would be provided hostel facility on sharing basis for the duration of their Programme in Delhi. The hostel facility will only include basic amenities like triple sharing accommodation in each room with attached bathroom (mattress is not included), table, chair and cupboard. Mess charges are not included as part of the accommodation and are to be borne by the intern availing the hostel facility. The hostel facility would be available from 2 days prior to the start of Programme and upto 2 days after the end of the Programme (e.g., for the internship batch starting 01.03.2024 and ending 30.04.2024, the hostel facility will be available from the forenoon of 28.02.2024 till the afternoon of 02.05.2024). Interns would be awarded with certificate on successful completion of the Internship Programme.
