The grant-in-aid is subject to the condition that, when the Scheme is closed or abandoned, the receipt from the disposal of assets, built out of the whole or a portion of the grant now sanctioned, will be shared between the Governments in proportion with their respective shares in the capital cost to assets.
- 4. The expenditure is debitable to the Major Head "3601" in Demand No. 105 Ministry of Women & Child Development under sub-head; 04-Grants for Centrally Sponsored Plan Schemes, 04.789-Special Component Plan for Schedule Castes (Minor Head), 14- Social Welfare-Child Welfare, 14.01-ICDS-General Component, 14.01.31-Grants-in-aid 2013-2014 (Plan)
- 5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.
