Subject : Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Kerala State Housing Board at Mulamkunnathukavu, Thrissur District, Kerala - Release of first installment.**


Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 3,94,76,000/- (Rupees Three Crore Ninety Four Lakh Seventy Six Thousand only) as Central Government's share for construction of a Working Women's Hostel for **142 Working Women** and Day Care Centre for 25 children at Mulamkunnathukavu, Thrissur District, Kerala. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 5,26,35,000/- (Rupees Five Crore Twenty Six Lakh Thirty Five Thousand only) as admitted for construction working women hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Kerala State Housing Board** of a sum of **Rs. 1,97,38,000/- (Rs. One Crore Ninety Seven Lacs Thirty Eight Thousand only)** being the **first installment** of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this installment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.




