
Sir,

In continuation of this Ministry's earlier sanction letter number 4(14)-4/2013-WH dated 31.03.2015 on the subject mentioned above I am directed to convey the sanction of the President for release of a further sum of **Rs. 15,00,000/- (Rs. Fifteen Lacs only)** including non-recurring grant of Rs. 7,50,000/- incurred towards the purchase of furniture and furnishing items, being reimbursement towards the **third & final** instalment of grant out of a non-recurring grant of Rs. 75,00,000/- (Rupees Seventy Five Lakh only) as Central Government's share for construction of a Working Women's Hostel for **100 working women** and Day Care Centre for **25 children** at Wangbal, Thoubal District, Manipur.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Rural Development Women Organisation** of a sum of Rs. 15,00,000/- (Rupees Thirty Lakh only) **being the third & final instalment** of the grant for construction of working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. This third & final instalment is being reimbursed on the basis of the completion documents submitted by the organization and therefore, **no separate Utilisation Certificate will be issued for this sanctioned amount.**

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
