Subject: Integrated Child Development Services (ICDS) Scheme - Release of Grants-in-aid to the State of Maharashtra during 2013-14 for continued implementation of the Scheme – Vth Instalment.

Sir,

I am directed to convey the sanction of the President to the payment of Rs.27,18,65,231/- (Rupees Twenty Seven Crore Eighteen Lakhs Sixty Five Thousand and Two Hundred Thirty One only) to the State Government of Maharashtra as fifth Installment of grant-in-aid during 2013-14 for the continued implementation of Integrated Child Development Services (ICDS) Scheme.

2. This grant-in-aid is towards the non-recurring and recurring expenditure for the ICDS Programme. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole vide Ministry of Finance letter No. 2(19)-P.II/60 dated 9.10.1964, as amended from time to time, addressed to all State Governments etc.
3. The grant-in-aid is subject to the condition that, when the Scheme is closed or abandoned, the receipt from the disposal of assets, built out of the whole or a portion of the grant now sanctioned, will be shared between the Governments in proportion with their respective shares in the capital cost to assets.
4. The expenditure is debitable to the Major Head `3601" in Demand No. 105, Ministry of Women & Child Development under sub-head; 04-Grants for Centrally Sponsored Plan Schemes, 04.358-Social Welfare-Child Welfare, 05-Integrated Child Development Services, 05.01-General Component, 05.01.31-Grants-in-aid 2013-2014 (Plan).
5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.


