Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in- to Andhra Pradesh Women's Co-operative Finance Corporation Limited, Hyderabad at Guntur Town, Guntur District, Andhra Pradesh - Release of first installment.

Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 1,70,25,000/- (Rupees One Crore Seventy Lakh Twenty Five Thousand only) as Central Government's share for construction of a Working Women's Hostel for **100 working women** and Day Care Centre for **30 children** at Guntur Town, Guntur District, Andhra Pradesh. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 2,27,00,000/- (Rupees Two Crore Twenty Seven Lakh only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

- 2. I am, accordingly, directed to convey the sanction of the President to the payment to the Andhra Pradesh Women's Co-operative Finance Corporation Limited, Hyderabad of a sum of Rs. 20,43,216/- (Rs. Twenty Lacs Forty Three Thousand Two Hundred Sixteen only) being the first installment of the grant for the construction of the building which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.
- 3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this instalment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.
- 4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
