4. The fund is to be utilized by the State Government for items mentioned in scheme guidelines with the overall aim and objective of the scheme.

5. The State Government will maintain separate records of expenditure incurred for implementation of OSC scheme and they are required to furnish separate Statement of Expenditure along with Physical Progress Report and Utilization Certificate. The State Government will submit Utilisation Certificate and Statement of Expenditure to Ministry of Women and Child Devlopment, Gol within 15 days of the start of next Financial Year.

6. The expenditure involved is debitable to Demand No.101, Major Head No. 3601-Grants-inaid to State Governments, 06-Centrally Sponsored Scheme, 101-Central Assistance, 82-Mission Shakti, 01-SAMBAL (Beti Bachao Beti Padaho/ One Stop Centre/ One Stop Centres/ Nari Adalat/ Mahila Police Vounteer etc.), 31-Grants-in-aid General of Sambal sub scheme during the financial year 2022-23.

7. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State of **Telangana** would be arranged through NEFT/ECS. The Payment of the State Government would be arranged through CAS, Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the

8. The accounts of the Grantee Institutions or Organizations shall be opened to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry or Department in terms of Rule 236(1) of GFR, 2017.

9. The State shall implement all provisions contained in the letter of the Department of Expenditure, Government of India dated 23rd March 2021 regarding SNA. The funds are to transferred to SNA account of State of Telangana through treasury.

10. The release of funds and monitoring further utilisation should be undertaken through PFMS. The Departments should establish a mechanism to ensure that the funds earlier released have been effectively utilised and that the data and facts reported relating to physical and financial performance are correct as per Rule 232(V), GFR-17.

11. All interests or other earnings against Grants-in-aid (other than reimbursement) released should be mandatorily remitted to the Consolidated Fund of India immediately in favour of PAO (WCD), New Delhi after finalisation of the accounts as per Rule 230(8), GFR-17.

12. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.

13. This sanction issues with the concurrence of AS & FA, WCD vide computer No. 3556 dated 30.03.2023.
