Madam/Sir

I am directed to refer to your letter No. 27/DC (N) 2017-2018 dated 06.04.2017 on the above cited subject and to convey the approval of the competent authority for revalidation of Rs. 6.67 Lakh (Rupees Six Lakh Sixty Seven Thousand only) remain available as unspent amount, with State Govt. / District Collector for implementation of BBBP Scheme during financial year 2017-2018.

2. The above fund remain unutilized out of Rs. 32.505 Lakhs (Rupees Thirty Two Lakh Fifty Thousand Five Hundred only) released to the North District of Sikkim for implementation of the Scheme of Beti Bachao Beti Padhao (BBBBP) scheme during the financial year 2016-17 vide letter of even number dated 17.10.2016. It may be ensured that the expenditure is made as per the schematic norms.

3. It is also intimated that the Ministry has accepted the UC and SoE in respect of North District of Sikkim for Rs. 25.835 Lakh. The **expenditure under the following components of BBBP Scheme are beyond the prescribed norms of the BBBP and hence, the**

141424/2017/BBP same will be borne the Govt. of Sikkim from its own resources. Component-wise expenditure made within the ceiling prescribed as per schematic norms has only been accepted .
