Subject: Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children, Grants-in-aid to **Bui Welfare Society, Arunachal Pradesh at Daporijo, Upper Subansiri District, Arunachal Pradesh** - Release of final installment.

Sir,

In continuation of this Ministry's sanction letter of even number dated 10.11.2016, I am directed to say that the Government of India had sanctioned a non-recurring grant of Rs. 4,81,35,000/- (Rupees Four Crore Eighty One Lacs Thirty Five Thousand only) as Central Government's share for construction of a Working Women's Hostel for **115 working women** and Day Care Centre for **35 children** at **Daporijo, Upper Subansiri District, Daporijo, Upper Subansiri District**. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 6,41,80,000/- (Rupees Six Crore Forty One Lakh Eighty Thousand only) as admitted for construction of the working women's hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Bui Welfare Society, Arunachal Pradesh** of a sum of **Rs. 56,76,000/- (Rs. Fifty Six Lacs Seventy Six Thousand only)** being Rs. 48,13,500/- as the final instalment of the grant for the construction of the building and Rs. 8,62,500/- as grant for furniture & furnishings for 115 women @ Rs. 7500/- per women.

3. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.
