Subject : Scheme of Assistance to Green Valley Educational Society, Assam for running Hostels in Rented Premises at Dag No. 447(0)/ 7178(N) K. Patta No. 1 of village Hatigaon, Mouza Beltola, Guwahati for Working Women with Day Care Centre for Children - Release of grant-in-aid.

Sir,

I am directed to say that the Government of India has approved the proposal of **Green Valley Educational Society, Assam** for running of Working Women Hostel in the rented building at **Dag No. 447(0)/ 7178(N) K. Patta No. 1 of village Hatigaon, Mouza Beltola, Guwahati** for 48 working women. Monthly rent of **Rs. 21,000/-** (Rs. Twenty One Thousand only) has been approved for hiring of hostel building for working women subject to the condition that in case the actual expenditure on this project is less than the approved rent, the difference between the approved rent and the actual expenditure will have to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to State Government of Assam of a sum of Rs. 4,03,508/- (Rs. Four Lacs Three Thousand Five Hundred Eight only) being the **partial payment of first instalment** out of Rs 5,49,000/- (Rs. 1,89,000/- as rent for July, 2017 to March, 2018 and Rs 3,60,000/- as one time non-recurring grant for purchase of furniture @ Rs. 7500 x 48) being the grant for running of working women hostel in rented premises. Secretary, Social Welfare Department, Government of Assam is requested to further release the fund to **Green Valley Educational Society, Assam**.

3. The Working Women Hostel is a sub-scheme of the Centrally Sponsored Umbrella Scheme "Mission for Protection & Empowerment for Women". In the above release, the Central Government and Implementing Agency contribution has been calculated as 75:25 ratio and sanction of funds is subject to the following conditions:

- (i) The amount of the grant will have to be utilised for all components under the scheme as per the schematic norms.
- (ii) The implementing agency shall also be required to contribute their share for implementation of the Working Women Hostel Scheme.

4. The grant is further subject to condition that the State Government will maintain separate records of expenditure incurred for implementation of Working Women Hostel and furnish separate Statement of Expenditure and Utilisation Certificate duly indicating the Physical Progress Report along with agency's share within **eight months** of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

5. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will revert to the Central Government.

The expenditure involved is debitable to Major Head "3601" Grant in aid to State Governments, 06- Centrally Sponsored Schemes (Sub Major Head), 101 -Central Assistance/Share (Minor Head), 48-Mission for Empowerment and Protection for Women (Sub Head), 05-Working Women Hostel (Detailed Head), 31-Grant-in-aid Construction (Object Head) under Demand No. 98, Ministry of Women and Child Development during 2018-2019 (Plan).
7. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.
8. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principals of the Scheme approved by the Competent Authority.
9. The sanction issues with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 23281/ JS & FA dated 20.04.2018.
10. Entry has been made in the GIA Register at Sl. No. 01.
