
**Subject: Revised Allocation of food grains to the State of Telangana under Wheat Based Nutrition Program and National Food Security Act (NFSA), 2013 to meet the Supplementary Nutrition under the Anganwadi Services Scheme during the 4<sup>th</sup> quarters for FY-2020-21 – reg.**

Sir/Madam,

In continuation of earlier Sanction Order No.17/1/2020-CD.III (e.82532) dated **2<sup>nd</sup> March, 2021** regarding allocation of foodgrains for 4<sup>th</sup> Quarter during FY 2020-21, I am directed to convey the revised allocation of foodgrains for a total **4705.5 MTs of Wheat also approved** by Ministry of Women & Child Development, Government of India to the **State Government of Telangana**, under **Wheat Based Nutrition Programme** and National Food Security Act (NFSA) at the subsidized price not exceeding ₹3/- per kg for Rice and ₹ 2/- per kg for Wheat. The other terms and conditions will be the same as mentioned in the earlier Revised Order dated 2<sup>nd</sup> March, 2021. **However, the State Govt. has already lifted the quantity of 4705.5 MTs Wheat Foodgrains for the 4<sup>th</sup> Quarter during Financial year 2020-21 from the FCI Hyderabad and utilized the same.**
