I am directed to convey the sanction of the President for payment of **Rs. 62,70,000/- (Rupees Sixty Two Lakh Seventy Thousand only)** to the Government of Tamil Nadu as grants-in-aid for **Setting up Women Helpline in Tamil Nadu under Universalisation of Women Helpline Scheme**. This amount includes **Rs. 44,70,000** towards recurring grant for the **1<sup>st</sup> half year of the financial year 2015-2016** and an amount of Rs. 18,00,000 towards non-recurring grant for **Setting up Women Helpline**.

4. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D-Wing, Ground Floor, New Delhi.


