I am directed to refer to your letter No. **1038/TS/SRCW/2014 dated 13.04.2017** on the above cited subject and to convey the approval of the competent authority for revalidation of Rs. 20.18351 Lakh (Rupees Twenty Lakh Eighteen Thousand Three Hundred Fifty One only) **remain available as unspent amount with Hyderabad District for implementation of BBBP Scheme during financial year 2017-2018.**

The above fund remain unutilized out of Rs. 36.19638 lakhs (Rupees Thirty Six Lakh Nineteen Thousand Six Hundred Thirty Eight only) which was revalidated vide this Ministry's letter No. 12045/1/2015-BBBP dated 28.06.2017 for utilisation under implementation of the Scheme of Beti Bachao Beti Padhao (BBBP) scheme in the Telanagana State and Hyderabad District during the financial year 2016-17. It may be ensured that the expenditure is made as per the schematic norms in Hyderabad District.

3. It is further requested to the Government of Telangana to surrender the unspent grant of Rs. 4.41263 Lakh remained with them as

on 31.03.2017, as State Level Component under the BBBP Scheme, to the PAO, Ministry of Women and Child Development, Government of India. The grant under State Level Activities is now not a part of BBBP Scheme as per revised scheme guidelines.
