**Subject: Release of recurring grant in aid to Govt. of Tripura for running 190 Crèches under the National Crèche Scheme for the Children of Working Mothers for the 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> quarter of FY 2017-18 & and for the 1<sup>st</sup>, 2<sup>nd</sup>, & 3<sup>rd</sup>, Quarter of 2018-19.**

Madam/Sir,

I am directed to convey the sanction of President of India to the payment of **Rs. 3,02,86,115/- (Rupees Three Crore Two Lakhs Eighty Six Thousand One Hundred & Fifteen only)** to the State Govt. of Tripura for the 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> quarter of FY 2017-18 and for the 1<sup>st</sup>, 2<sup>nd</sup>, & 3<sup>rd</sup>, Quarter of 2018-19 grant-in-aid (80% Gol's share) for running 190 crèches under National Crèche Scheme for Children of Working Mothers.

2. The proposal has been examined in the Ministry and approval is hereby conveyed for incurring an expenditure of **Rs. 3,02,86,115/- (Rupees Three Crore Two Lakhs Eighty Six Thousand One Hundred & Fifteen only)** as reimbursement of grant-in-aid for 188 Crèches in 2<sup>nd</sup> Quarter, 184 Crèches in 3<sup>rd</sup> Quarter and 182 Crèches in 4<sup>th</sup> Quarter of 2017-18 under the National Crèche Scheme for the period 01.07.2017 to 31.03.2018 as per the following details:

# The grant total number of children enrolled for nine month in 2<sup>nd</sup> quarter has been worked out to 234507 on the basis of document furnished by the State Govt. of Tripura. Accordingly Central component of Supplementary nutrition @ 80% of Rs.12 per child has been calculated to Rs 22, 51,267/--

As per the details above the total admissible grant for 3 quarters of the year 2017-18 comes to (Rs. 41,63,247/- + RS. 44,49,188/- + Rs. 42,77,280/-) = Rs. 1,28,89,715/- (Rupees One Crore Twenty Eight Lakhs Eighty Nine Thousand Seven Hundred & Fifteen Only).

Release of admissible grant for 3 quarters of the year 2018-19 upto December 2018 comes to (Rs. 60,26,800/- + Rs. 56,46,800/- + Rs. 57,22,800/-) = 1,73,96,400/- (Rupees One Crore Seventy Three Lakhs Ninety Six Thousand Four Hundred only).

**Total amount release of Rs. 3,02,86,115/- (1,28,89,715 + 1,73,96,400/-).**

3. The fund sharing pattern among the Central Government, State Government and organisation/institution running the crèches will be in the ratio 80:10:10 and sanction of funds is subject to the following conditions:

- The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- The States/UTs/NGOs shall also be required to contribute their share for implementation of the National Crèche Scheme.
- Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-DARPAN portal and have furnished details of Unique ID from NGO-DARPAN portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

4. The grant is further subject to condition that the State Govt. will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

5. Details of progress of expenditure on National Crèche Scheme form 1st April to 30th September must be furnished by 15th October and for the period from 1st October to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.

6. The expenditure of **Rs. 3,02,86,115/- (Rupees Three Crore Two Lakhs Eighty Six Thousand One Hundred Fifteen only)** is debitale to the 3601 -Grants-in-aid to State Governments, (Major Head), 06-Centrally Sponsored Schemes (Sub Major Head), 101-Central Assistance/Share (Minor Head), 47-ICDS (Sub-Head), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.98, Ministry of Women & Child Development 2018-19 (Plan).

8. This sanction issues with the concurrence of IFD vide their e-office Computer No.32789 dated 12.03.2019.


